<p>The subject is a SFR 2 story, containing 2116sqft, 4bed/2.1bath, which was built in 2011 and is located near highway, non residential properties and retail stores and will not affect the subject. It was necessary to use a comparable listing with superior in condition due to limited market activity in the subject's area. It was necessary to use a comparable listing with a pool due to limited market activity in the subject's area. The difference in bed count due to the neighborhood area is hard to find comparable that is similar to the subject bed count. It was necessary to exceed the lot size variance guideline of 25% in an effort to use the best available comparable from within the subject's market area. In order to include comparable to reinforce the subject's GLA and other attributes, the sold comparable search was exceeded over 3 months up to 6 months time. In delivering final valuation, most weight has been placed on CS1 and CL2 as they are most similar to subject condition and overall structure.</p>

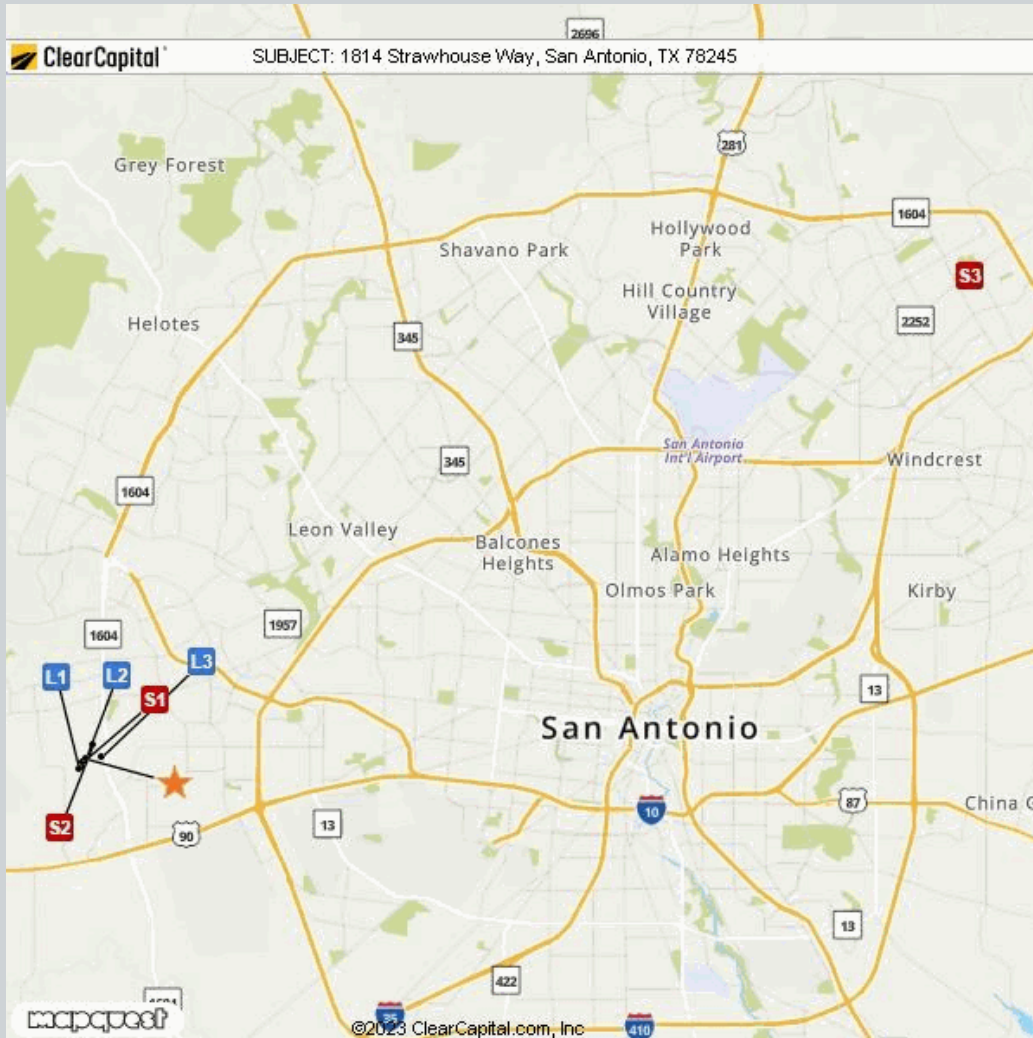
