<b>Comments Regarding Pricing Strategy</b>		
<p>The subject is located in a suburban residential neighborhood close to major roads, rail road tracks, commercials, retail amenities and close to other non residential properties. There are no apparent adverse factors which should affect the subject's marketability. Within 1 mile +/-30% GLA and +/-30 year built there were not enough comps, thus it was necessary to exceed search parameters. To find comparable that reinforced the subject's GLA, age, and condition necessitated a search using distances over one mile. Due to dearth of comps in the subject same side it was necessary to exceed major roads and rail road tracks. To maximize the accuracy of initial valuation, I have elected to increase the time span of closed sales past the favorable 3-month window to find comparable that required the fewest net adjustment. The tolerance of bed/bath, lot size, style and garage was exceeded to find comps. The year built of the comps available in the subject market were superior than that of the subject, hence was unable to bracket the year built of list comps. At the time of sale the sold comparable 1 and 2 properties may have had multiple offers or a concession was given and not noted. The BPO report must take these sales into consideration in terms of comparable selection. In delivering final valuation, most weight has been placed on CS2 and CL1 as they are most similar to subject condition.</p>

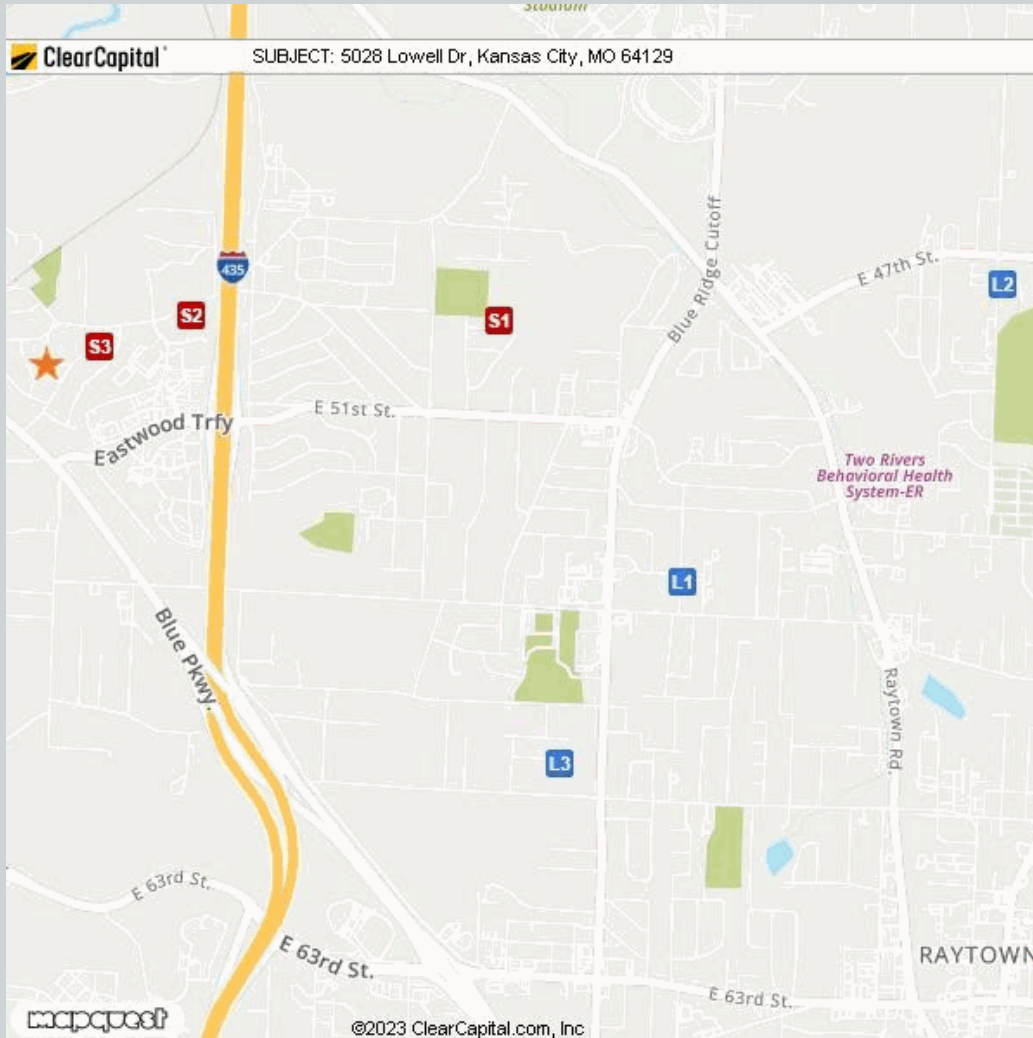
