Sold adjusted values are fairly consistent. Final value is weighed most heavily on Sold Comp 1 as it is proximate, appears to be most similar and is a recent sale. Due to the lack of similar sold comps, I had to use sold comps that Sold over 3 months ago. It is common and expected, due to the year built of homes in this area, that some sort of upgrade or remodel would be typical simply due to normal wear and tear of various components. This expectation would also apply to Subject Property. As an example, original carpeting has already worn out. Homeowner would typically replace with whatever is in style at that time, rather it be tile or wood laminate flooring. 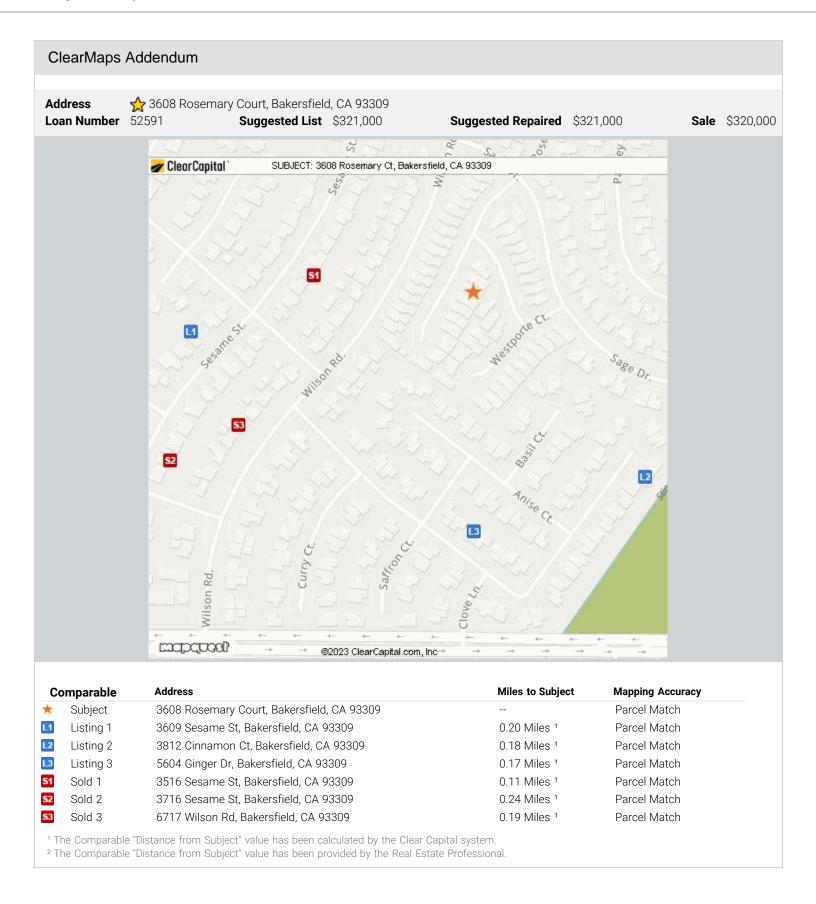
