<p>Within 1 mile, +/-20% GLA, +/-20 year built guidelines and 12 months back, there were limited comparable available. Therefore, it was necessary to exceed condition, lot size, closed date guidelines. Due to the lack of comparable that fell within the subject's bracketed square footage, it was necessary to search further back than three months up to twelve months (but used due to stable market conditions). Due to limited comps available, list comps were despite not bracketing the GLA since they were considered to be reliable comparable. Comparable(CS2, CS3) received multiple offers which resulted in an increased final sale price relative to list price. The value and marketability will not be affected with the subject being located near highway, worship place, railway track, school and commercial buildings. Comparable used in this report are from same location and neighborhood. In delivering final valuation, most weight has been placed on CS2 and LC1, as they are most similar to subject condition and overall structure. Subject attributes are from Tax record.</p>

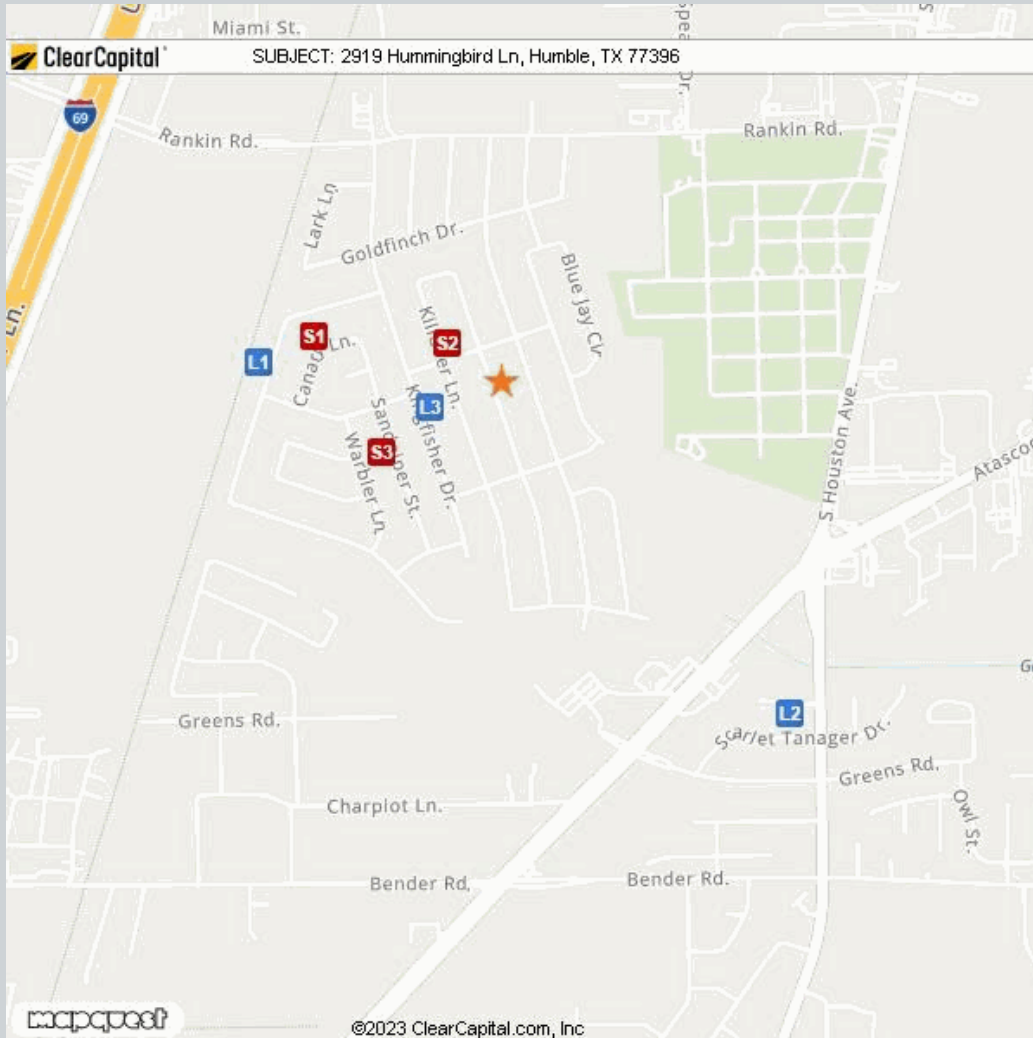
