<p>The subject is an SFR townhouse with GLA 1650 sq ft. In order to stay within 1 mile proximity, it was necessary to exceed GLA by +/- 30% and bed/bath count. Due to the limited availability of similar condition comps, it was necessary to use superior condition comps. In order to include comparable to reinforce the subject's GLA and other attributes, the sold comparable search was broadened to 12 months time. The subject seems to locate near highways, school, other non residential properties, and commercial space, this does not have any impact on current market value. In delivering the final valuation, the most weight has been placed on CS2 and LC2, as they are most similar to subject conditions and overall structure. Subject details are taken from the tax record.</p>
