The difference in bed count due to the neighborhood area is hard to find comparable that is similar to the subject bed count. In delivering final valuation, most weight has been placed on CS2 and CL2 as they are most similar to subject condition and overall structure.</p>

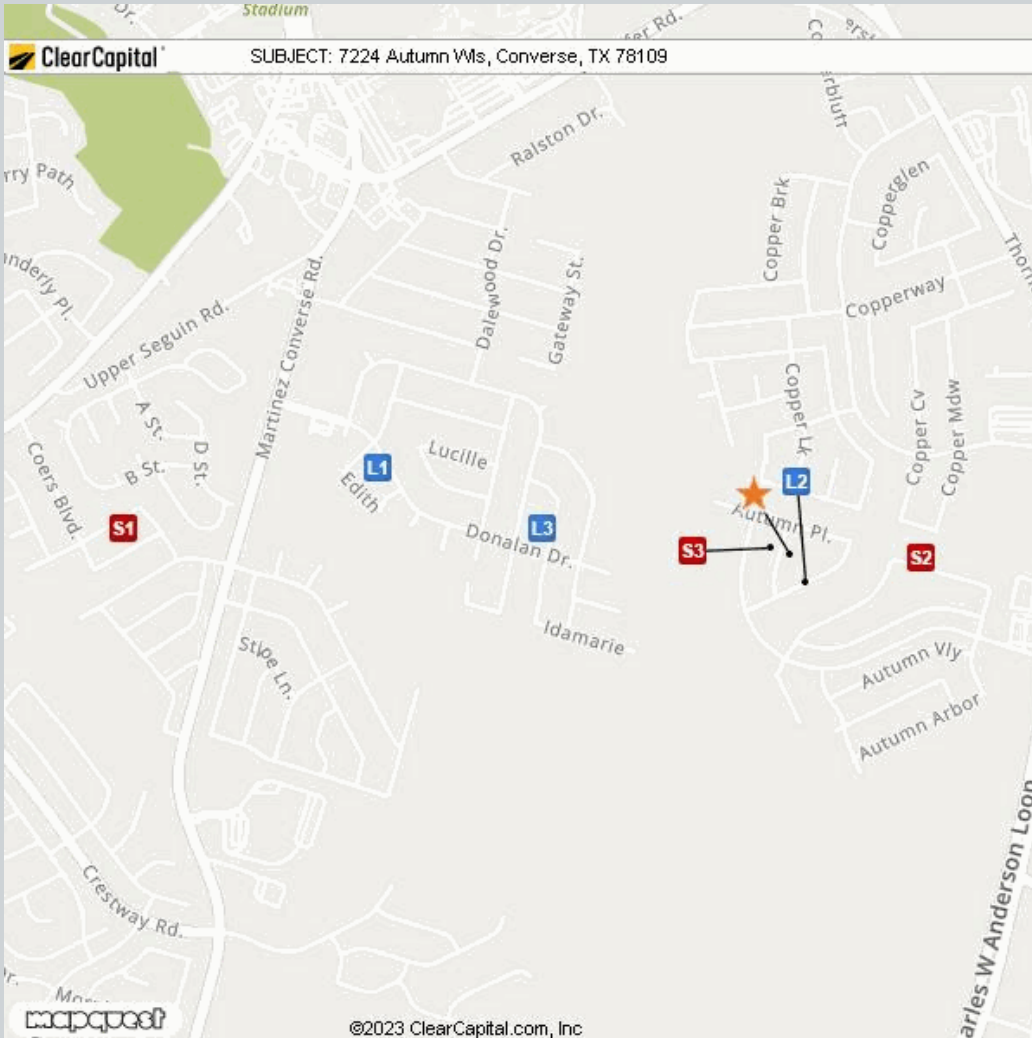
