#### **Comments Regarding Pricing Strategy**

Pricing suggestion came about from analyzing the most current comps which are located as close to subject as possible and are as close as feasible in square footage, rooms, style and acreage with subject property. Due to the lack of more suitable comparisons, it was necessary to exceed over 1 mile from the subject, over 6 months from inspection date, guidelines for lot size, bed/bath count and some recommended guidelines when choosing comparable properties. All the necessary adjustments are made. Comparable S1 and S3 received multiple offers which resulted in an increased final sale price relative to list price. The price range is over 25% and all sold comps are not within 15% from the subject's value due to a lack of similar comps. This variance could not be avoided and the comps were chosen for their similarities to the subject. Due to limited comps in the area, 2 sales with contract dates within 120 days of the effective date of the report could not be provided. Sold 1 and List 2 were overall most similar to the subject. The external influences near the subject such as water bodies, park and busy road which do not have an impact on the subject's marketability or value based on my Real Estate experience and knowledge of the local area.




