The value as of today is \$320000. Value best supported by sold comp 3 and list comp 3 is the most comparable to the subject. Proximity to the highway would not affect subject's marketability and both sides of the highway are similar market areas. Commercial presence for the subject would not affect the subject's condition or marketability. 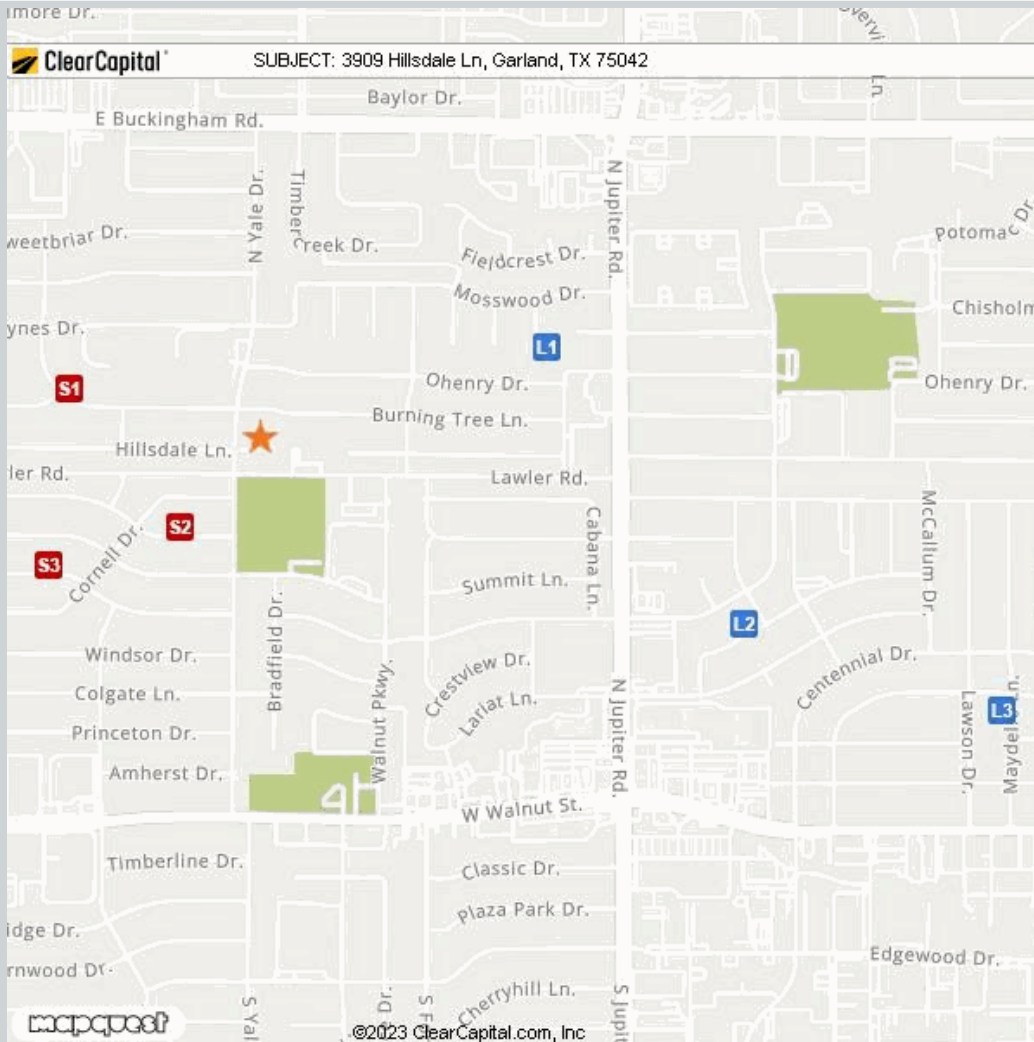
