Inventory remains below what is considered a balanced market. Days on market is averaging around 29, down from the prior month. Homes are averaging 99% list to sales price ratio. The suggested list price is based upon comparable sales used in account with current market conditions. Also based on exterior inspection only- interior condition could dramatically affect the value of the property.</p>		

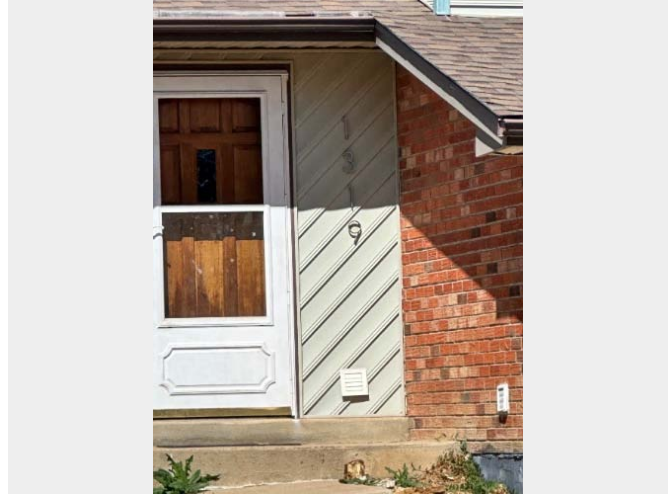

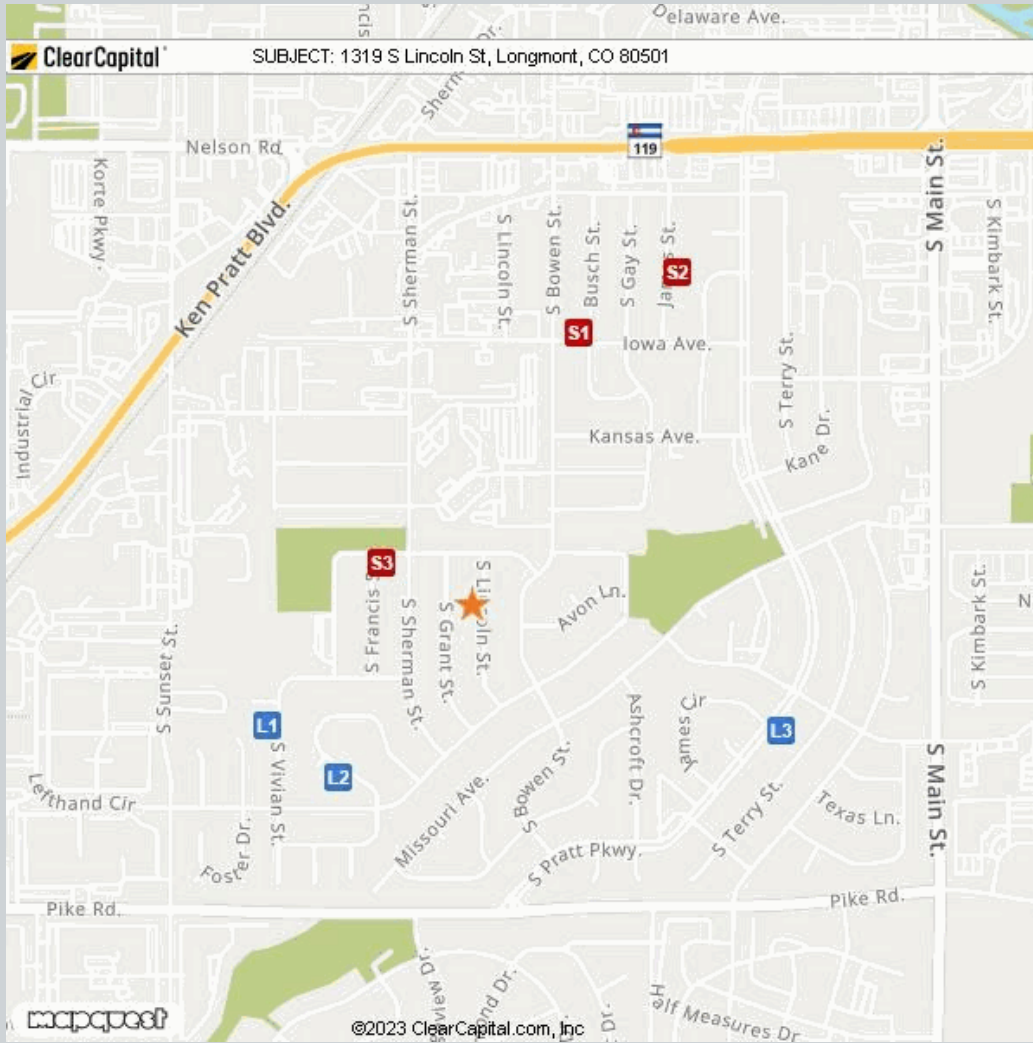
