<p>Subject details are taken from tax record. The subject is located near to park, school, highway, major roads and commercial buildings this will not have any impact on subject marketability as similar location comparable were used in this report. It was necessary to exceed the proximity to the subject guideline of 1 mile in an effort to use the best available comparable from within the subject's market area. Within 1 mile +/-20% GLA, +/-20 year built there were limited comparable available so it was necessary to exceed proximity. Proximity has been extended to 1.16 miles in order to provide the most accurate and similar comps in the subject market. There were limited similar comparable within this market area, which made it necessary to expand the bed and bath room count range to find properties to bracket the subject and comparable of similar location. In delivering final valuation more weightage is been placed on CS1 and CL2 were selected as the best available comparable as they are most similar to subject condition and overall structure. Priced according to current market activity. The comparable used were the best available at the time of report. To find comparable within proximity, price range was widened. Had to use comparable that had sale dates beyond 180 days because there are limited subjects within the home's radius. Comparable S1 S2 received multiple offers which resulted in an increased final sale price relative to list price. It was necessary to use a comparable with superior in condition due to limited comparable availability in the subject's area. Due to the limited similar criteria comps as that of subject, active comps were not bracketing the GLA as they are still considered to be reliable comparable.</p>

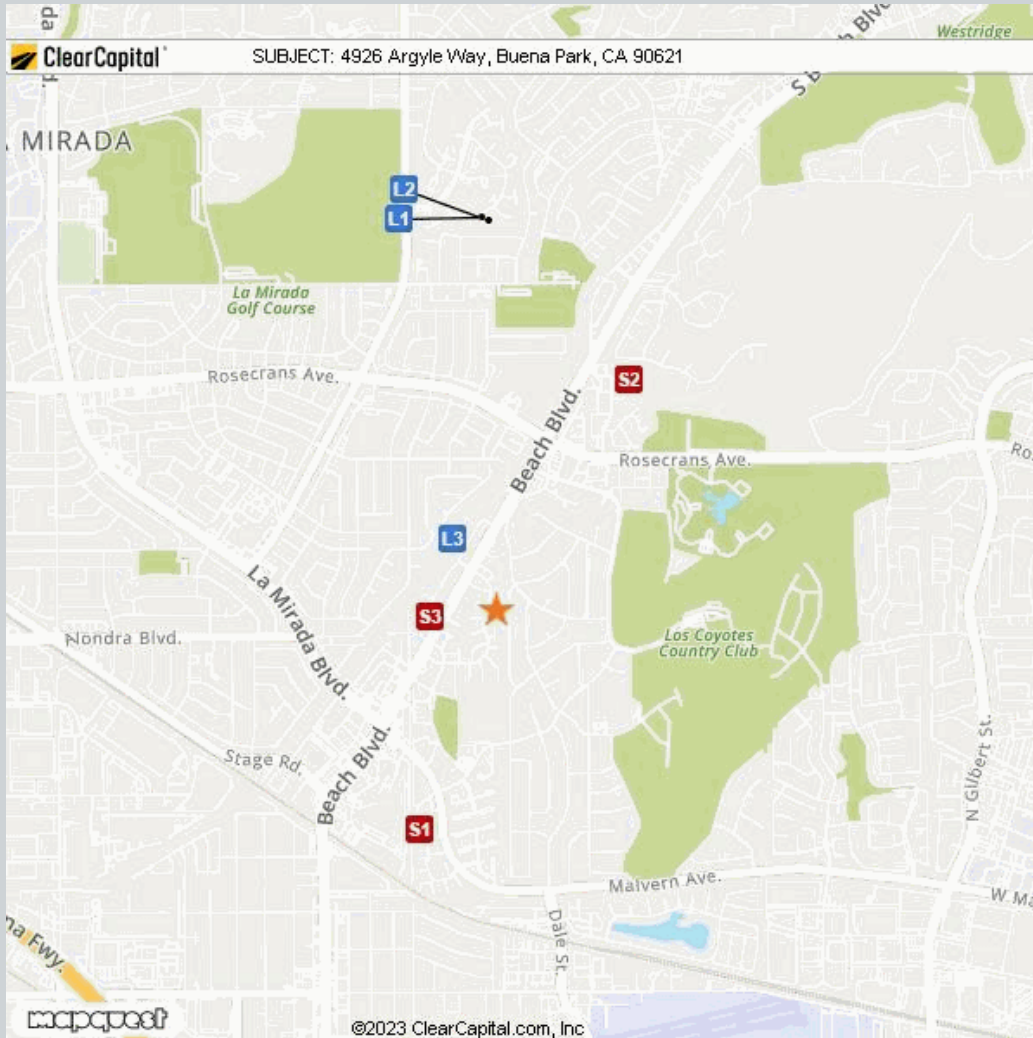
