Sales 1 and 2 received the most weight on the subject's Price due to their similar attributes. The subject property is a single family home, which is in overall average condition on the exterior. Comps for this report were searched for within a distance of 1 Mile and back up to 12 months in time. Sold comps have been searched for beyond 3 months time as there were limited recent similar sales in this area, especially average condition comps. The GLA Tolerance searched for similar comps was +/- 20% of the subject's Sq. Ft. The subject is in average exterior condition and there is a shortage of similar average condition comps. It was necessary to use two superior condition comps within this report. Inventory is decreasing, and demand is stable within the subject's market area. 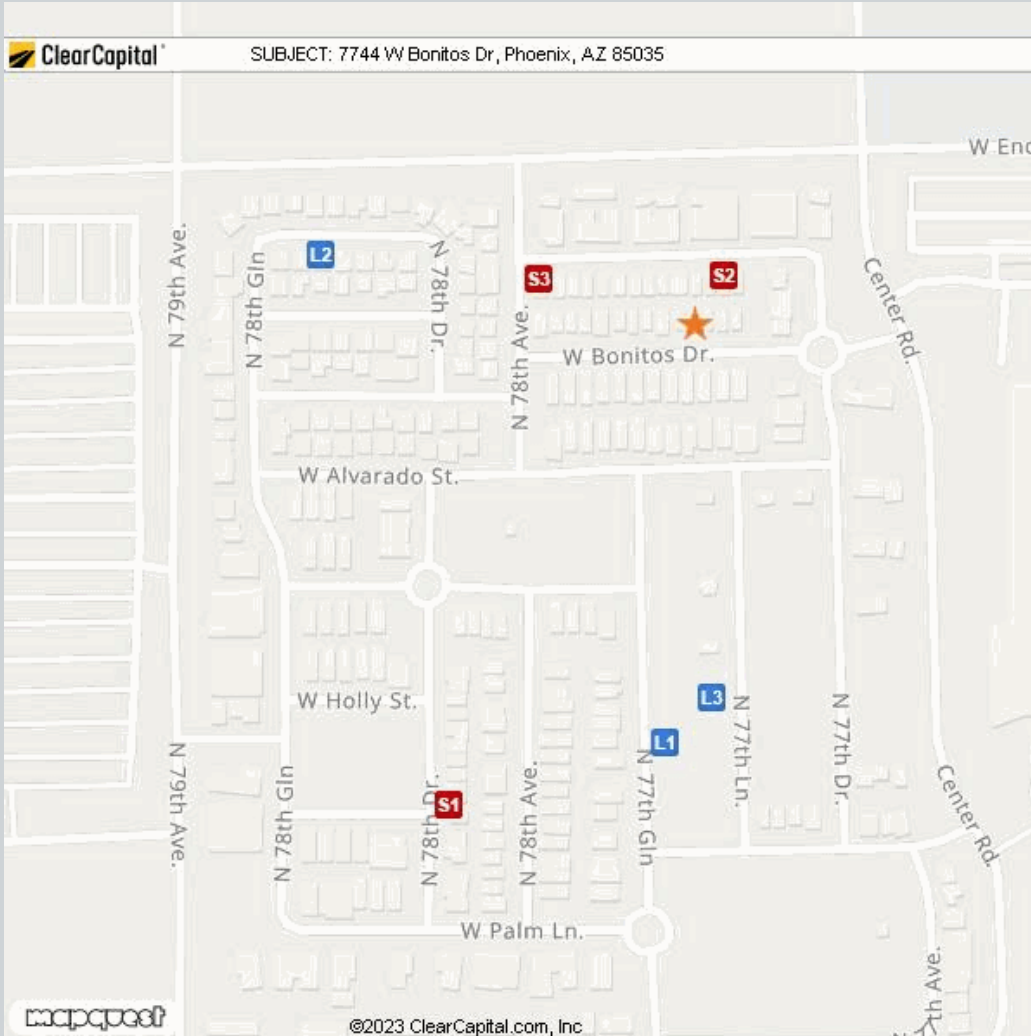
