#### **Comments Regarding Pricing Strategy**

The subject is a SFR 1 story, containing 1721sqft, 4bed/2bath, which was built in 1975 and is located near school, retail stores and non residential properties and will not affect the subject. It was necessary to use a comparable listing with superior in condition due to limited market activity in the subject's area. I was not able to bracket bed and style in list and lot size, because most of the comparable available within 1 miles are inferior to the subject lot size and bed, but have made appropriate adjustments for each difference in the physical feature. In order to include same street comps, the sold comparable search was exceeded over 3 months up to 12 months time. In delivering final valuation, most weight has been placed on CS1 and CL2 as they are most similar to subject condition and overall structure.






