Comments Regarding Pricing Strategy

The subject is a SFR 2 story, containing 2045sqft, 4bed/3bath, which was built in 1995. Comparable with styles dissimilar to the subject (but with similar attributes) were used to provide a basis for the subject's GLA. It was necessary to use a comparable listing with superior in condition due to limited market activity in the subject's area. The difference in bed count due to the neighborhood area is hard to find comparable that is similar to the subject bed count. I was not able to bracket in lot size, because most of the comparable available within 1 miles are inferior to the subject lot size, but have made appropriate adjustments for each difference in the physical feature. In order to include comparable to reinforce the subject's GLA and other attributes, the sold comparable search was exceeded over 3 months up to 6 months time. In delivering final valuation, most weight has been placed on CS2 and CL2 as they are most similar to subject condition and overall structure.

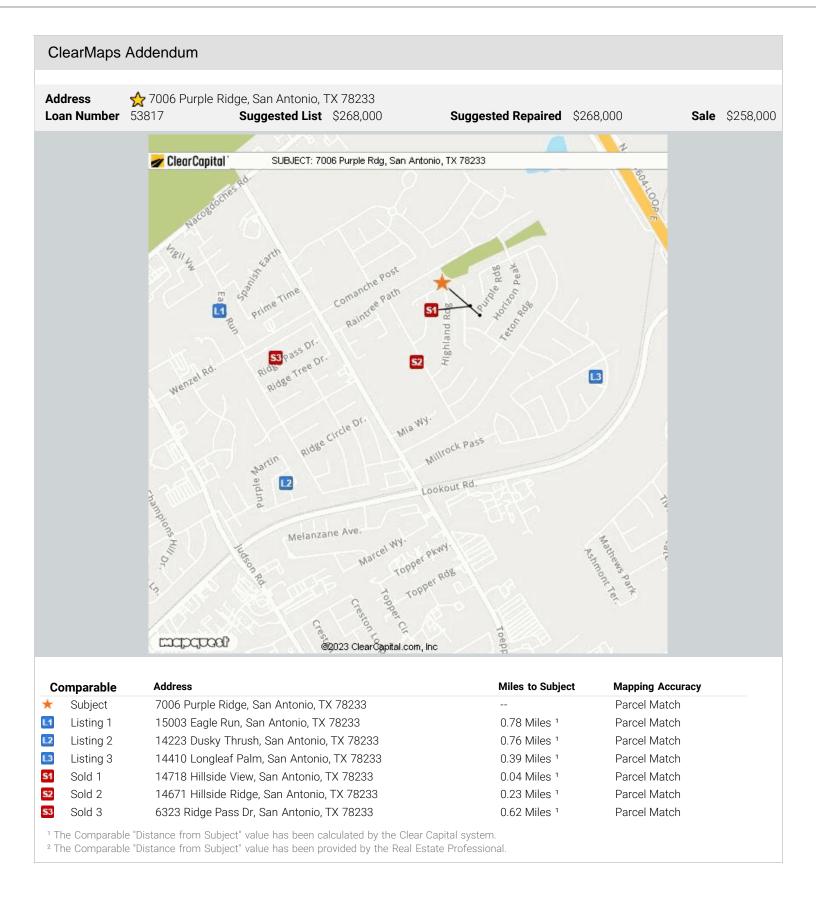
