It was necessary to exceed the threshold for age variance of 5 years in an effort to use the best available comparable from within the subject's market area. It was necessary to use a comparable listing with superior in condition due to limited market activity in the subject's area. It was necessary to exceed the lot size variance guideline of 25% in an effort to use the best available comparable from within the subject's market area. In order to include comparable to reinforce the subject's GLA and other attributes, the sold comparable search was exceeded over 3 months up to 6 months time. In delivering final valuation, most weight has been placed on CS2 and CL2 as they are most similar to subject condition and overall structure.




