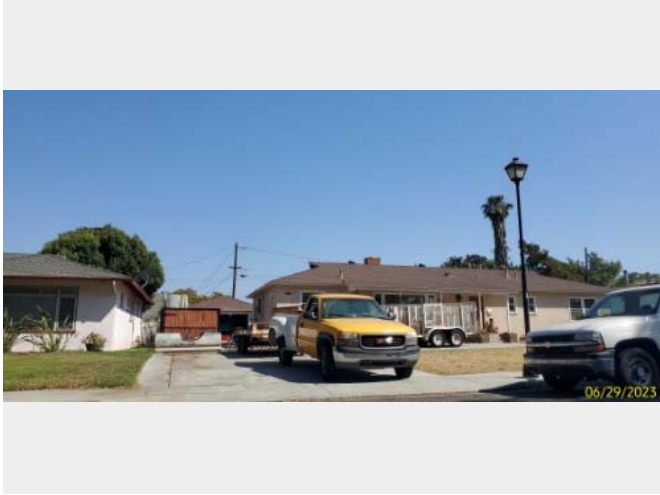
### Comments Regarding Pricing Strategy

In delivering final valuation, most weight has been placed on CS2 and LC2 as they are most similar to subject condition and overall structure. Market values remained stable during the last 12 months within the subject's market area.

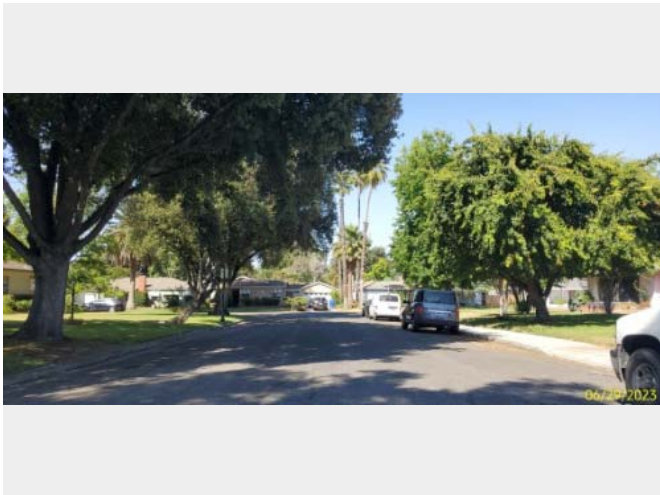

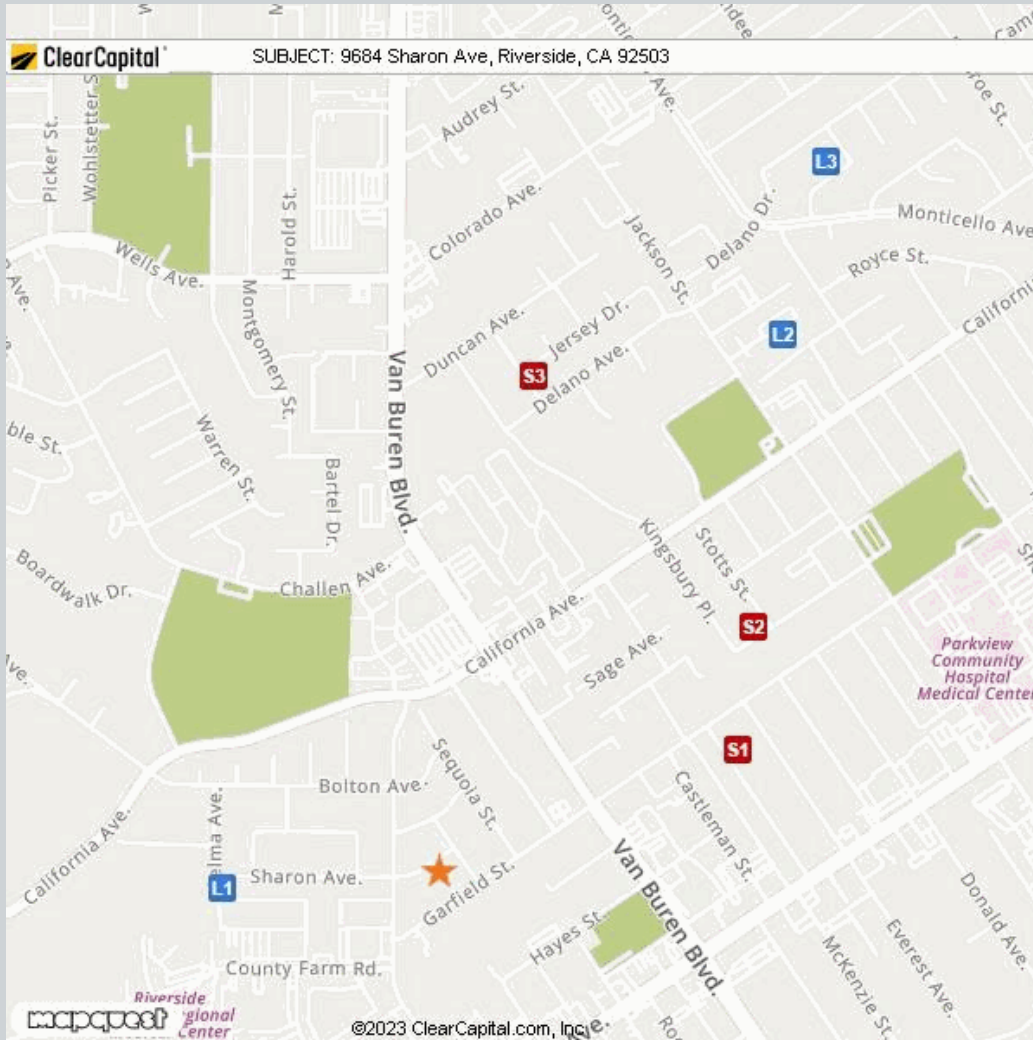
