**Sold 1** Sold one offers an added half bathroom (-\$2,500) and more square footage (-\$5,000) than the subject, but theme only offers a carport (\$3,500).

**Sold 2** Comparable two is almost identical to the subject property only requiring a small square footage adjustment (-\$1,700).

**Sold 3** Sold three shares the identical floor plan and similar square footage as the subject, but offers some interior updates (-\$10,000).

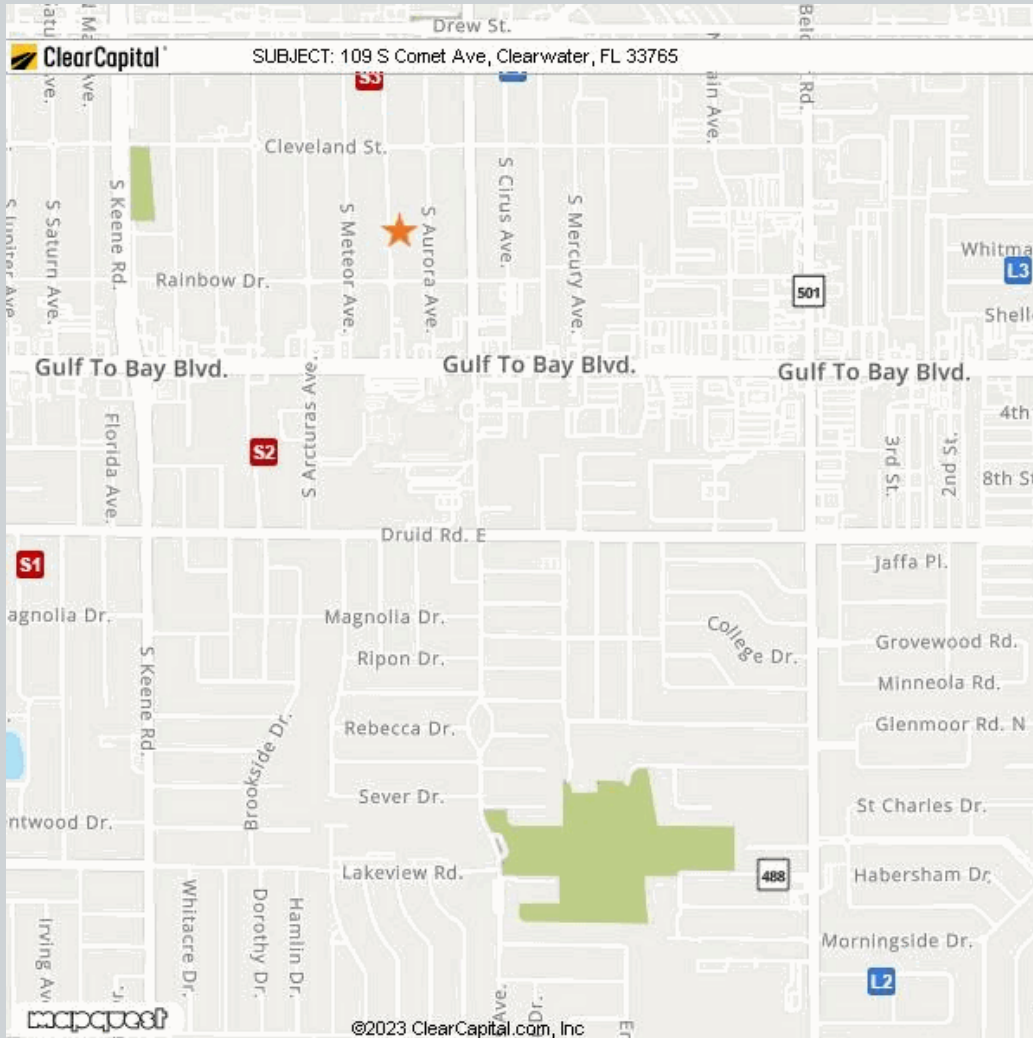
