Subject property is noted to be in average condition from the exterior and is located in a residential area of similar homes with no adverse external influences noticed. I went back 12 months, out in distance 2 miles, and even with relaxing glra search criteria I was unable to find any comps which fit the requirements. Within 2 miles and back12months I found10comps of which I could only use3due to lot size factors. The ones used are the best possible currently available comps within2miles and the adjustments are sufficient for this area to account for the differences in the subject and comps</p>

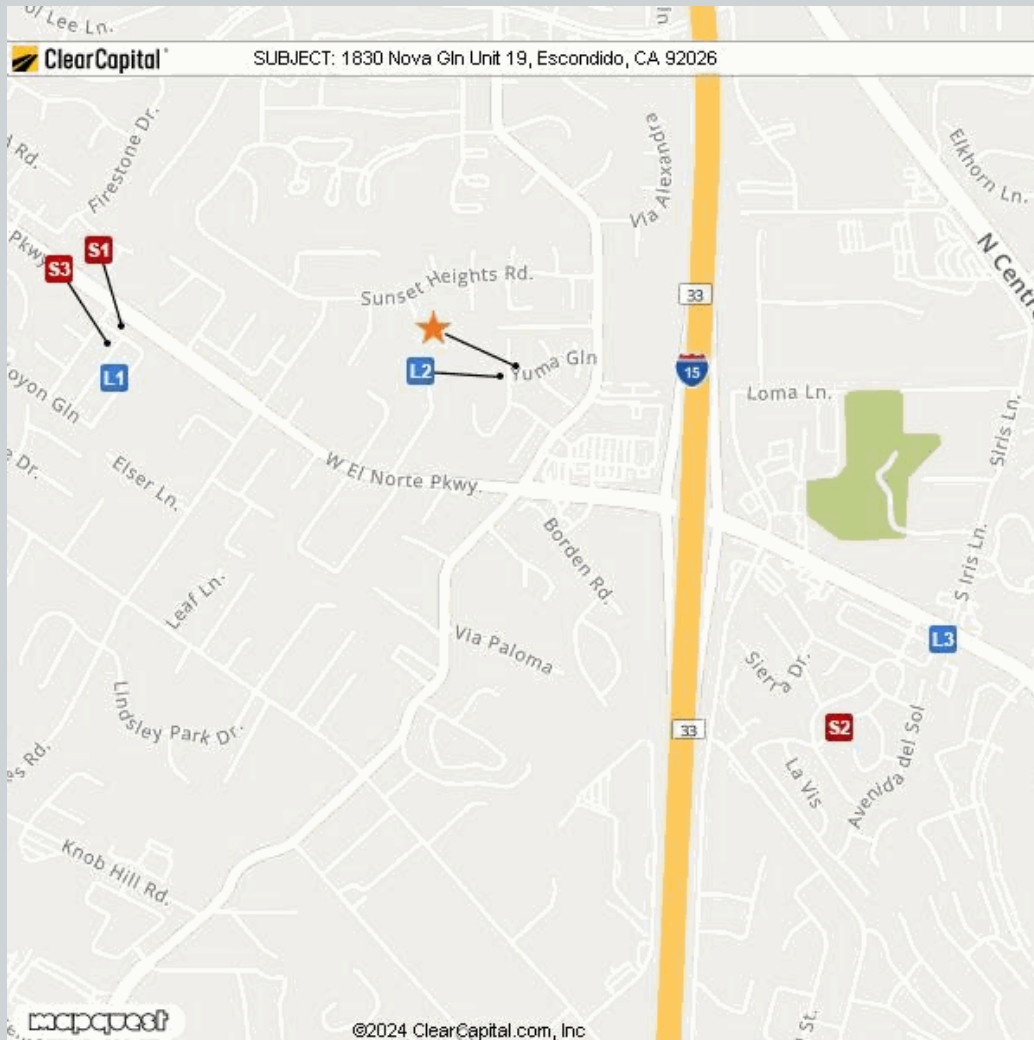
