Proximity to the highway and commercial would not affect subject's marketability and both sides of the highway and commercial are similar market areas.</p>

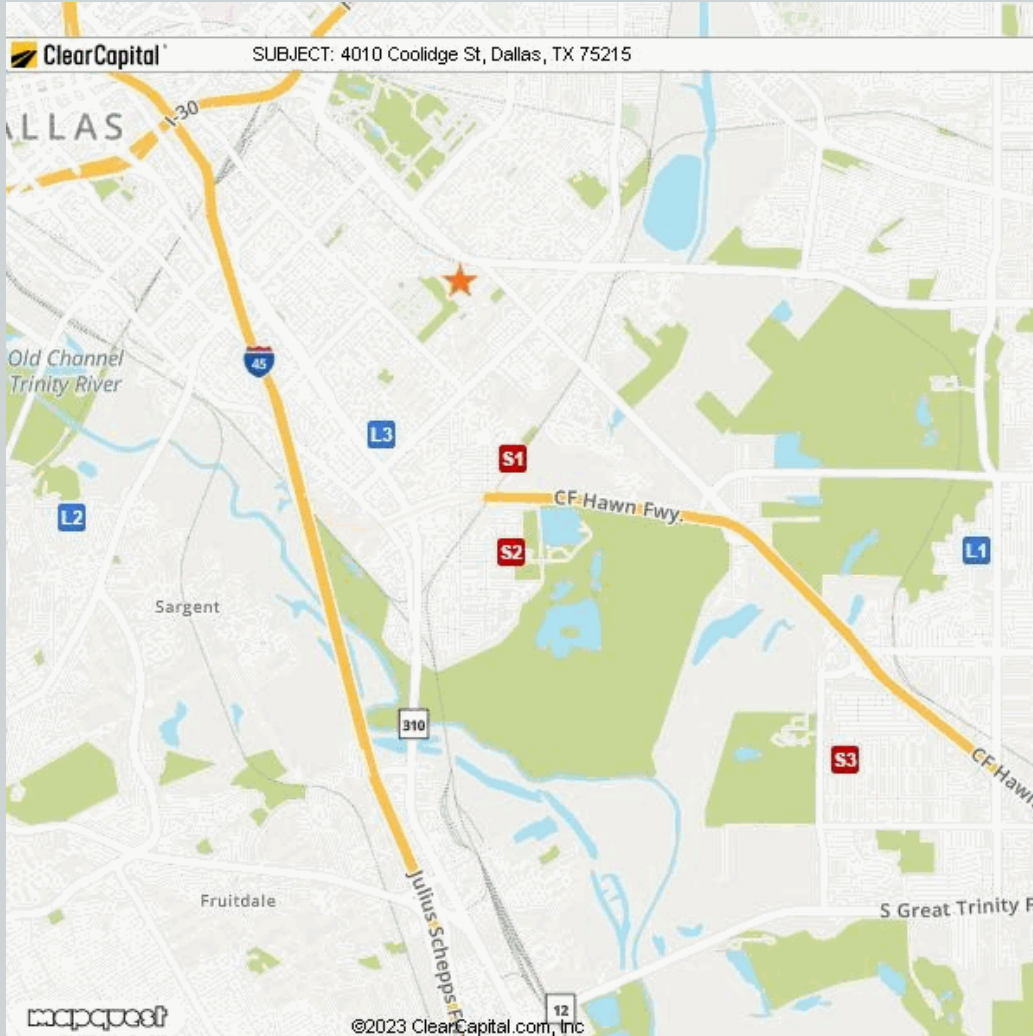
