All comps chosen have the similar locational influences and would be considered to be within subjects comparative market area. Most likely buyer would be owner occupied. Stockton is a town with several zip codes, all comps chosen would be considered to be within subjects competitive market area with different zip codes considered. Due to lack of list comps I had to expand the search to 2 mile radius. Schools, places of worship, highway, playgrounds and parks in the area do not have a negative impact on desirability, marketability or value of subject. Due to age of subject and comps, some updates should be expected as maintenance. Comps chosen are the most mid range average comps available in subject's neighborhood. 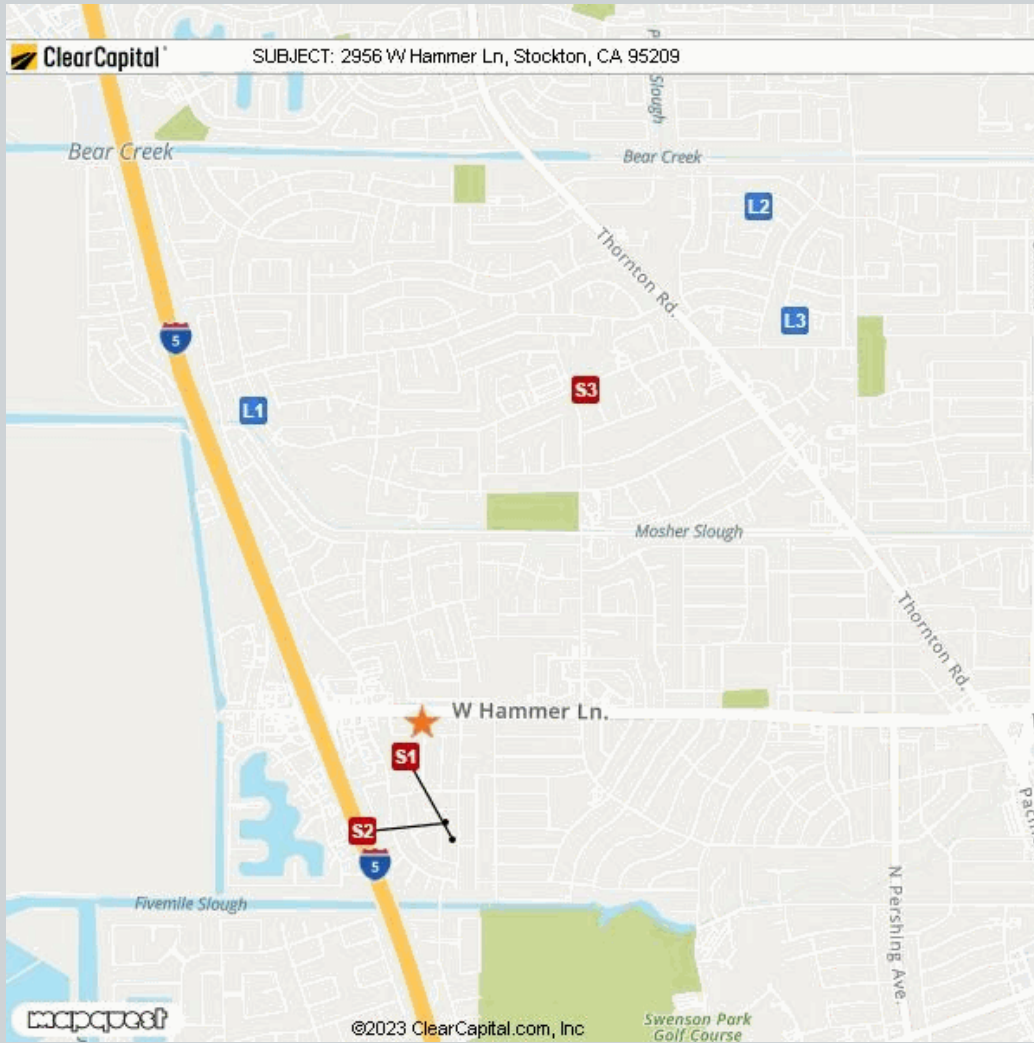
