| <p>Pricing suggestion came about from analysing the most current comps which are located as close to subject as possible and are as close as feasible in square footage, rooms, style and acreage with subject property. I have searched a distance up to 1.5 mile, GLA +/- 20%, year built +/- 20 and up to 12 months back. Due to the lack of more suitable comparisons, it was necessary to exceed over 1 mile from the subject, over 6 months from inspection date, guidelines for bed/bath count and some recommended guidelines when choosing comparable properties. All the necessary adjustments are made. Comparable S1, S2, and S3 received multiple offers which resulted in an increased final sale price relative to list price. The price range is over 25% and all sold comps are not within 15% from the subject's value due to a lack of similar comps. This variance could not be avoided and the comps were chosen for their similarities to the subject. Due to limited comps in the area, 2 sales with contract dates within 120 days of the effective date of the report could not be provided. There were no comparables found within 3 miles having similar lot size/year built/style/bed count/view. Sold 1 and List 3 were overall most similar to the subject. The external influences such as school, parks, worship places, and commercial near the subject do not have an impact on the subject's marketability or value based on my Real Estate experience and knowledge of the local area. Subject is located across the highway with no noise barrier. This will have a negative effect on value &amp; marketability. Comparable S2 and L1 have similar location influence as subject. Subject details were taken from tax records.</p> |             |                |

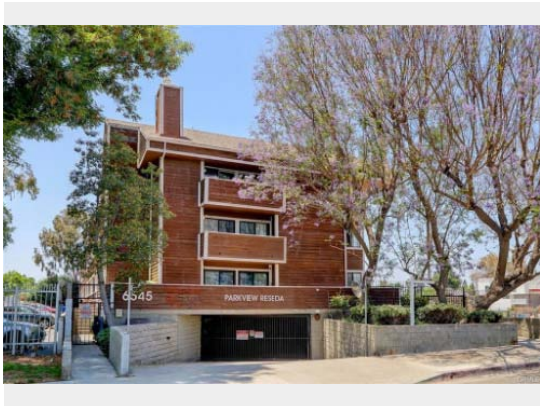

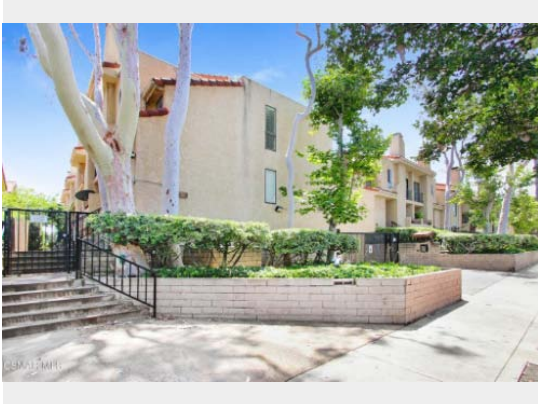

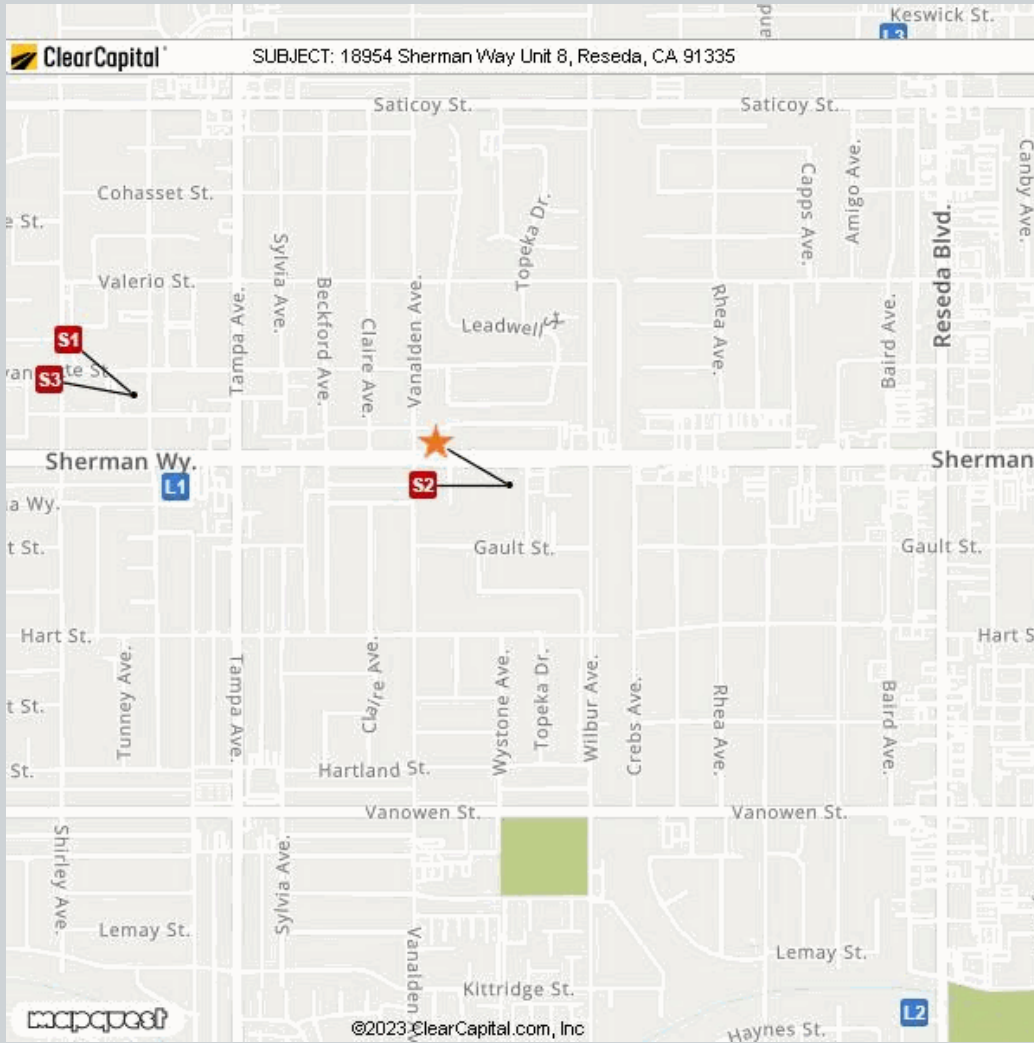
