Due to limited comparable, need to exceed proximity up to 1.83 miles, closed date, condition, year built, basement, garage and lot size. Due to limited comps it was unable to bracket the year built for active. Subject is located closer to residential, commercial, busy roads, place of worship, school. This however, will not have effect on value and marketability. Sale 2 and listing 2 are most comparable to the subject. Their value was weighted heavily in determining the value of the subject. Subject details were taken as per tax record. There was no mailbox number. Address was verified by surrounding house numbers.</p>		

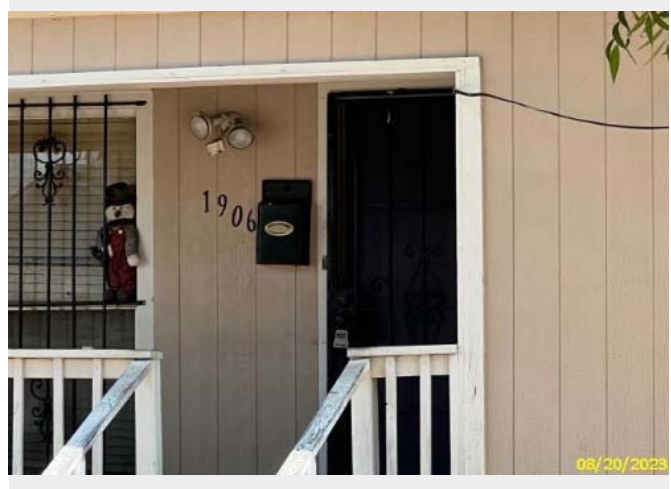

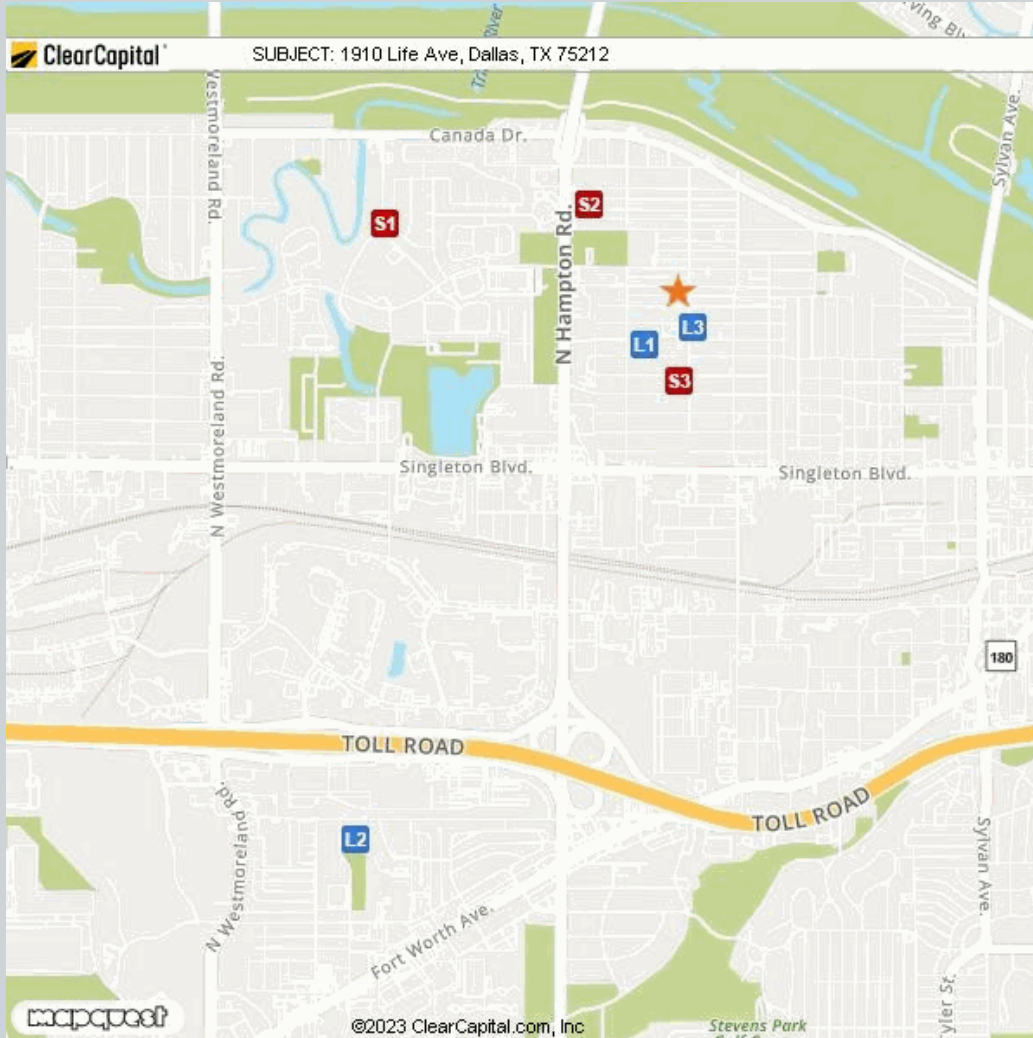
