In delivering final valuation, most weight has been placed on CS2 and LC2 as they are most similar to subject condition and overall structure. Comparable S1, S2, and S3 received multiple offers which resulted in an increased final sale price relative to list price.Due to limited comps in the area, it was necessary to exceed proximity up to 3 miles.






