<p>I have searched a distance up to 1.2 mile, gla +/- 20% sqft, lot size 30% +/- sq ft, age 10% +/- yrs and up to 12 months in time. There were limited comparable available with similar characteristics. Therefore, I was forced to exceed proximity (1.2 mile), style, bed / bath count, garage and lot size. I used what was available and the comparable selected were considered to be the best available. The comps however are valuable and bracket the subject well in terms of condition and size. Most weight has been placed on CS1 and LC1 as they are most similar to subject condition and overall structure.</p>

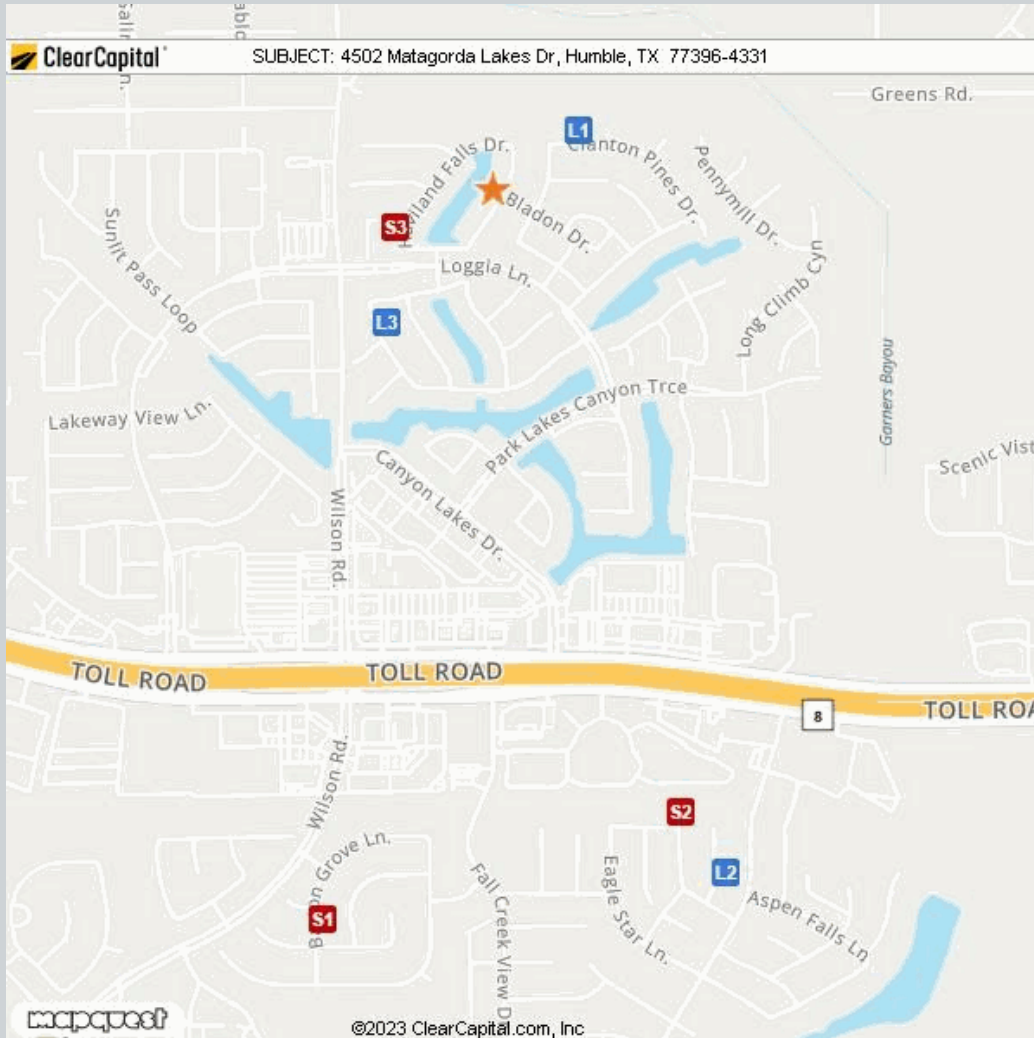
