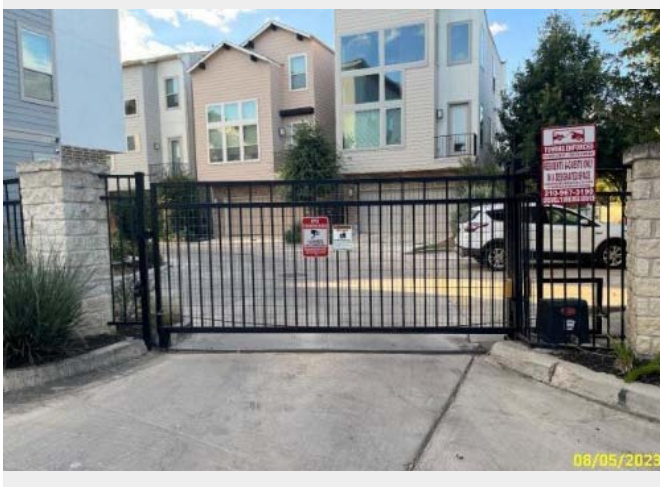

<p>The sale and listing search was conducted based on fair market pricing in the subject area. condition, year built, style, closed date, bed/bath count and lot size parameters were expanded to keep comps in the neighborhood. Used sales over 3 months old due to the lack of more recent sales from the subject's immediate area. Price range was over 15%in difference due to the neighbourhood area hard to find comparable that is similar to subject in condition and criteria. Subject is located near main road, park, school, worship place and commercial buildings. Due to limited comparable from same location, it was necessary to use comparables from across the main road. However, this won't affect the market value. In delivering final valuation, most weight has been placed on CS2 and LC3, as they are most similar to subject condition and overall structure. Subject attributes are from Tax record.</p>

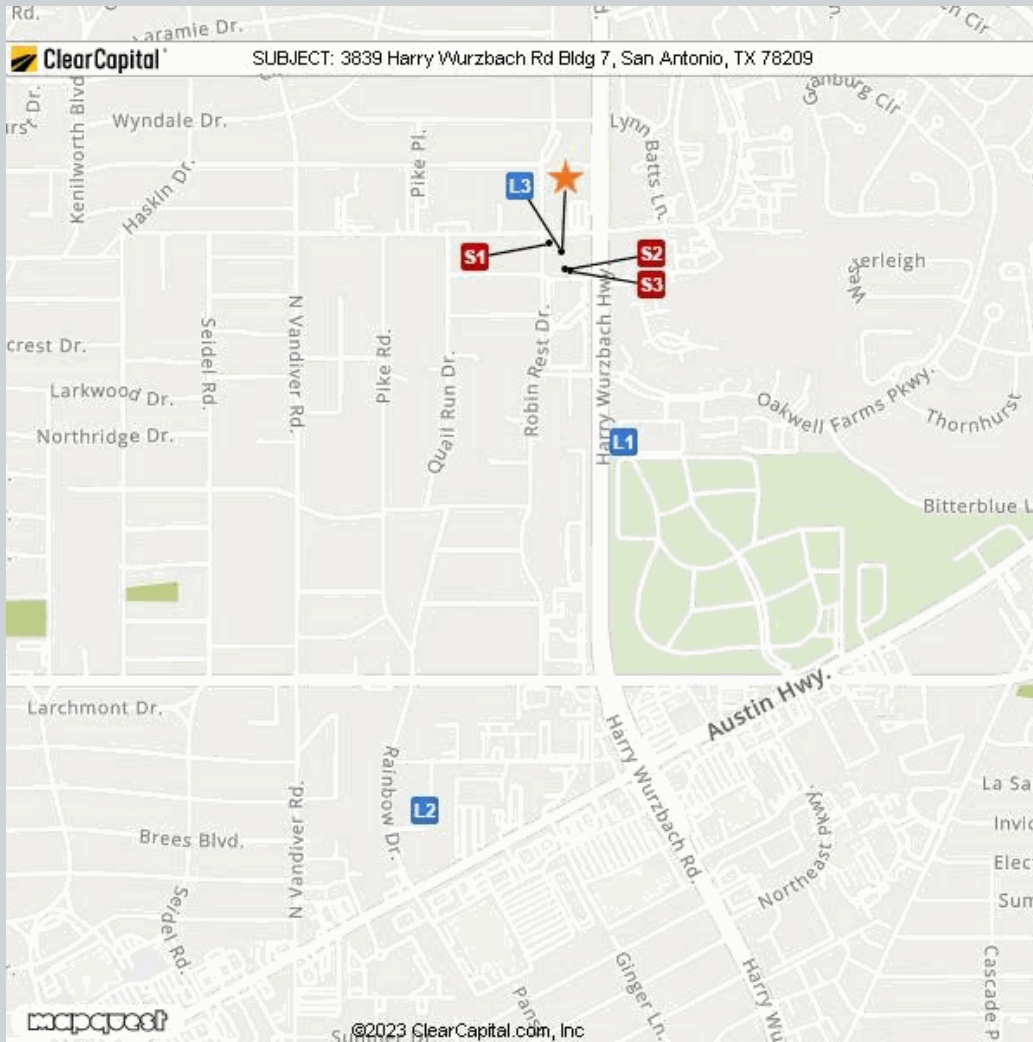
