<p>To locate comparables, it was necessary to exceed bed/bath count, style, view, lot size, and condition in the report. Due to limited number of comparables, close dates exceeded 3 months for sold comps. The MLS search criteria looked for comparables with a GLA range of 1411 to 2117 sq ft. In order to bracket the subject's GLA and condition, a search for comps was broadened to exceed proximity up to 2 miles. All comparables have similar location factors and support subject value and marketability. Comparable (CS3) received multiple offers which resulted in an increased final sale price relative to list price. In delivering final valuation, the most weight has been placed on CS1 and LC3, as they are most similar to subject condition and overall structure. Subject details are from tax records.</p>

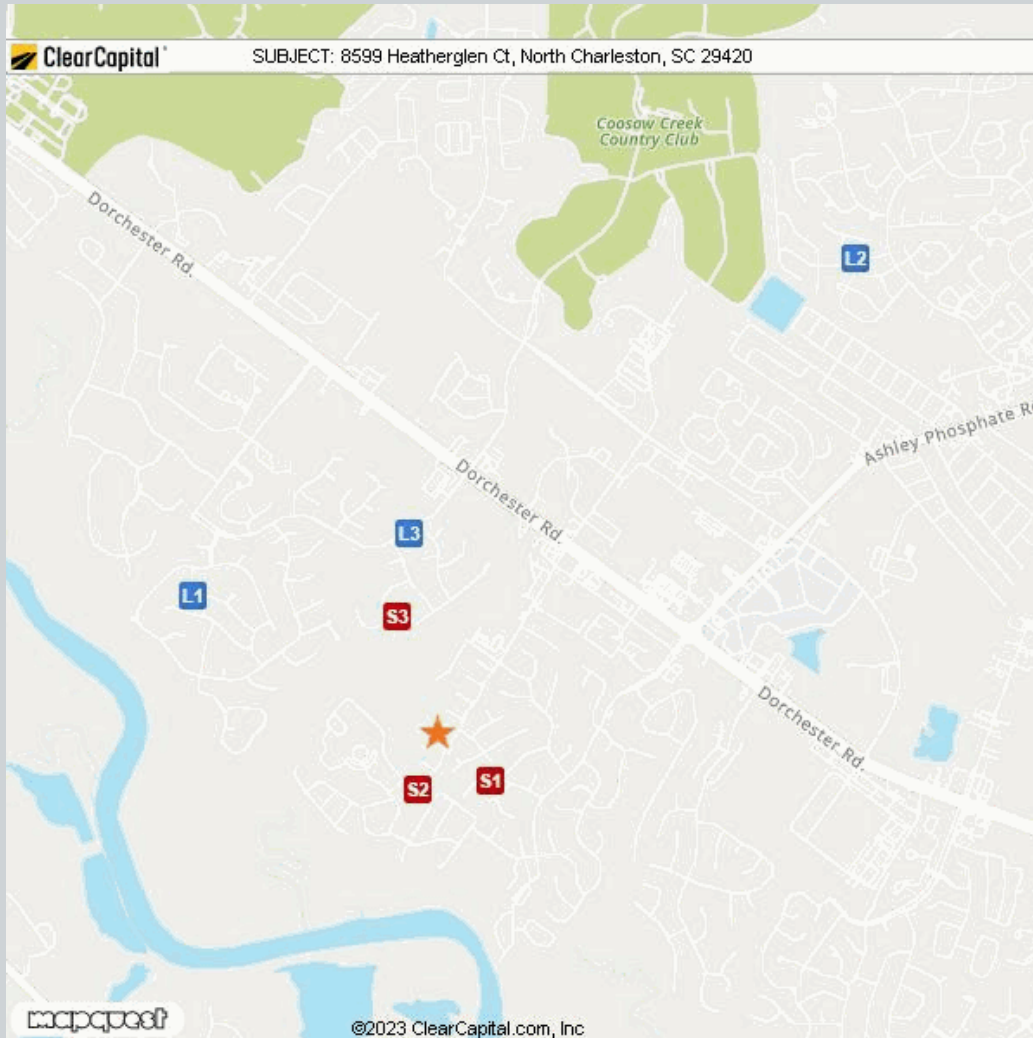
