<p>The choice of comps has been made in terms of proximity to the subject and appears to be the best available at this moment. The utilized comps are as similar in GLA, Style and Age as possible. All the guidelines of a proper search have been met. Subject's value has been determined by utilizing the values indicated in recent sales and current listings of comparable properties. The value has been estimated based upon best available comps in the same condition as the Subject also used comparable with variance 6 months and proximity extended upto 3 miles. In delivering final valuation, most weight has been placed on CS2 and LC2 as they are most similar to subject condition and overall structure. Garage count was verified by MLS comment and or pic. Subject's final value represents a value with normal marketing time and based on the most similar and proximate comps in this report and they were the best indicators of value available.</p>

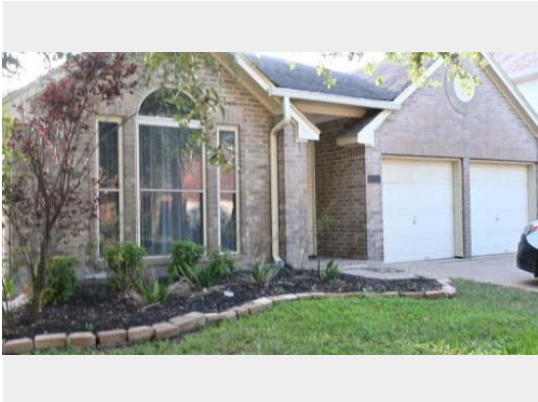

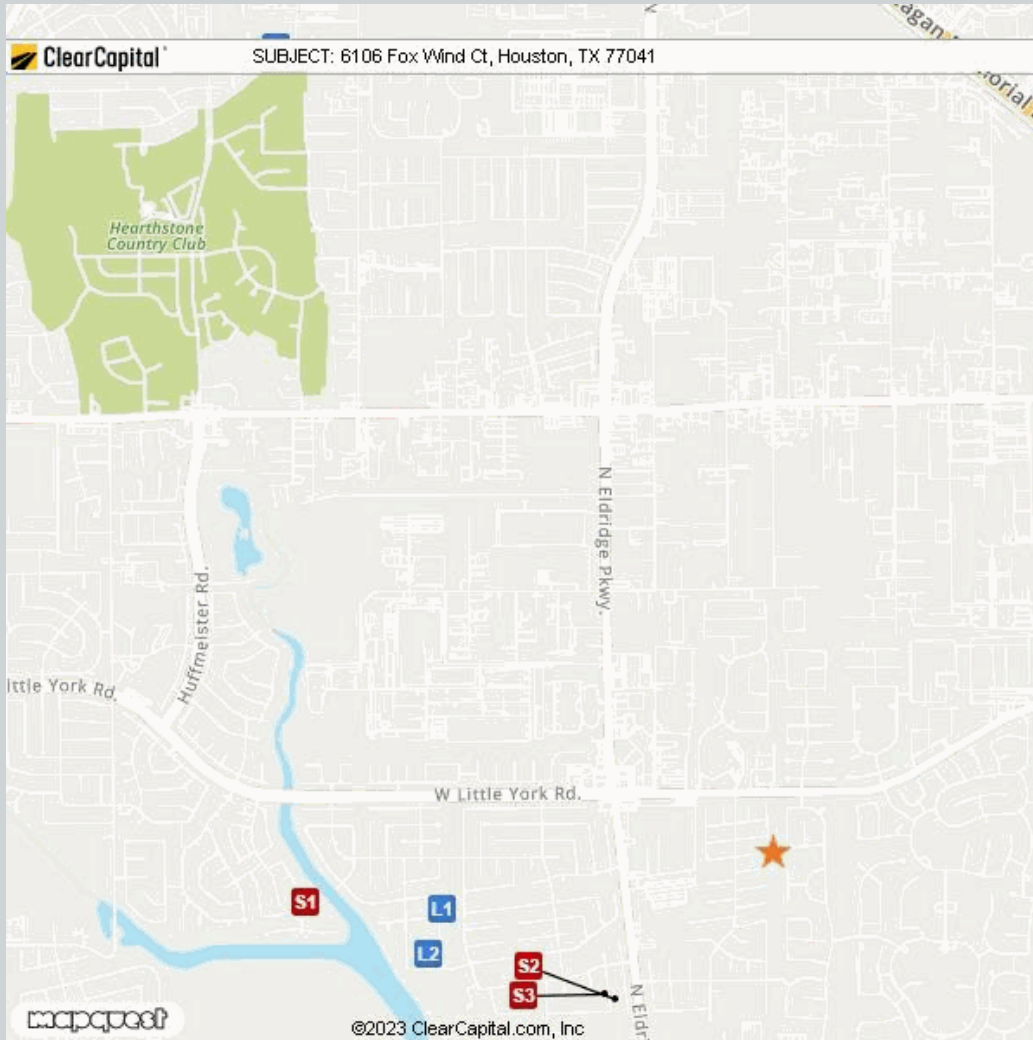
