<p>The distance guideline was expanded up to 2 miles in order to locate a comparable that would support the subject's GLA, Age and Condition. GLA, year built and lot size tolerances for comparable were expanded in order to locate comparables that were supportive of the subject GLA and other attributes. In order to include comparable to reinforce the subject's GLA and other attributes, the sold comparable search was broadened to 12 months time. Due to limited comps in the area, list comp were used despite not bracketing the gla as they are still considered to be reliable comparable. Due to limited comps in the area, list comp were used despite not bracketing the lot as they are still considered to be reliable comparable. Comparable S1 and S3 received multiple offers which resulted in an increased final sale price relative to list price. Subject details were taken from tax record . Comparable condition was verified by MLS comments and interior pics. Garage count was verified by MLS comments and pics. Subject is located closer to the main road and commercial area. This however, will not have an effect on value . More weight has been given to CS3 and LC2 which are similar in GLA and maintain the overall value and structure related to the subject</p>

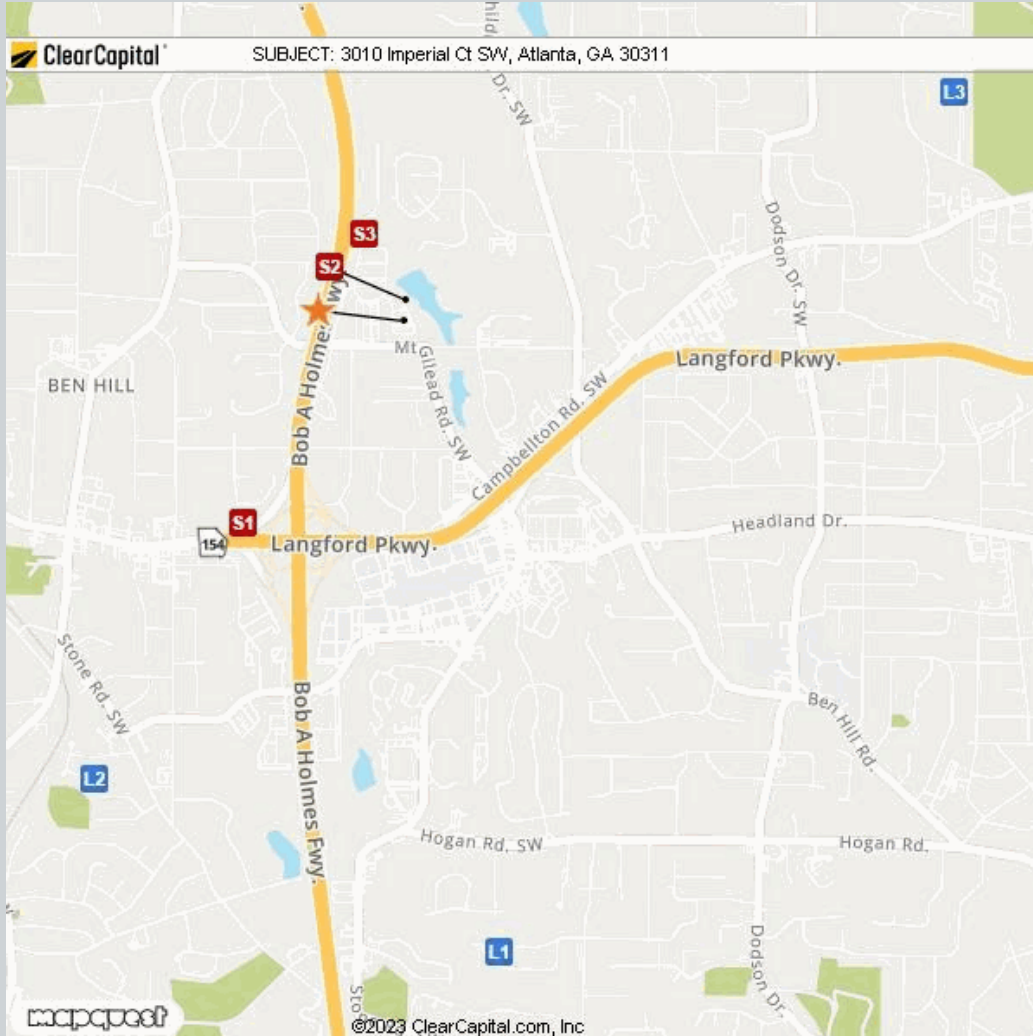
