Comments Regarding Pricing Strategy

To maximize accuracy of initial valuation, it was vital to extend the time span of closed sales past the great 6 month window to discover comparable that required the least net adjustment. In an effort to better bracket the feature set of the subject it was necessary to exceed the bed/bath count guideline. Comparable S1 received multiple offers which resulted in an increased final sale price relative to list price. Due to limited comps in the area, 2 sales with contract dates within 120 days of the effective date of the report could not be provided. The value and marketability will not be affected with the subject being located near park, main road, RR track, school and commercial area. To reach a value conclusion, most weight was placed on CS1 and LC1, as they are most similar to subject condition and overall structure. Subject details are taken from tax.

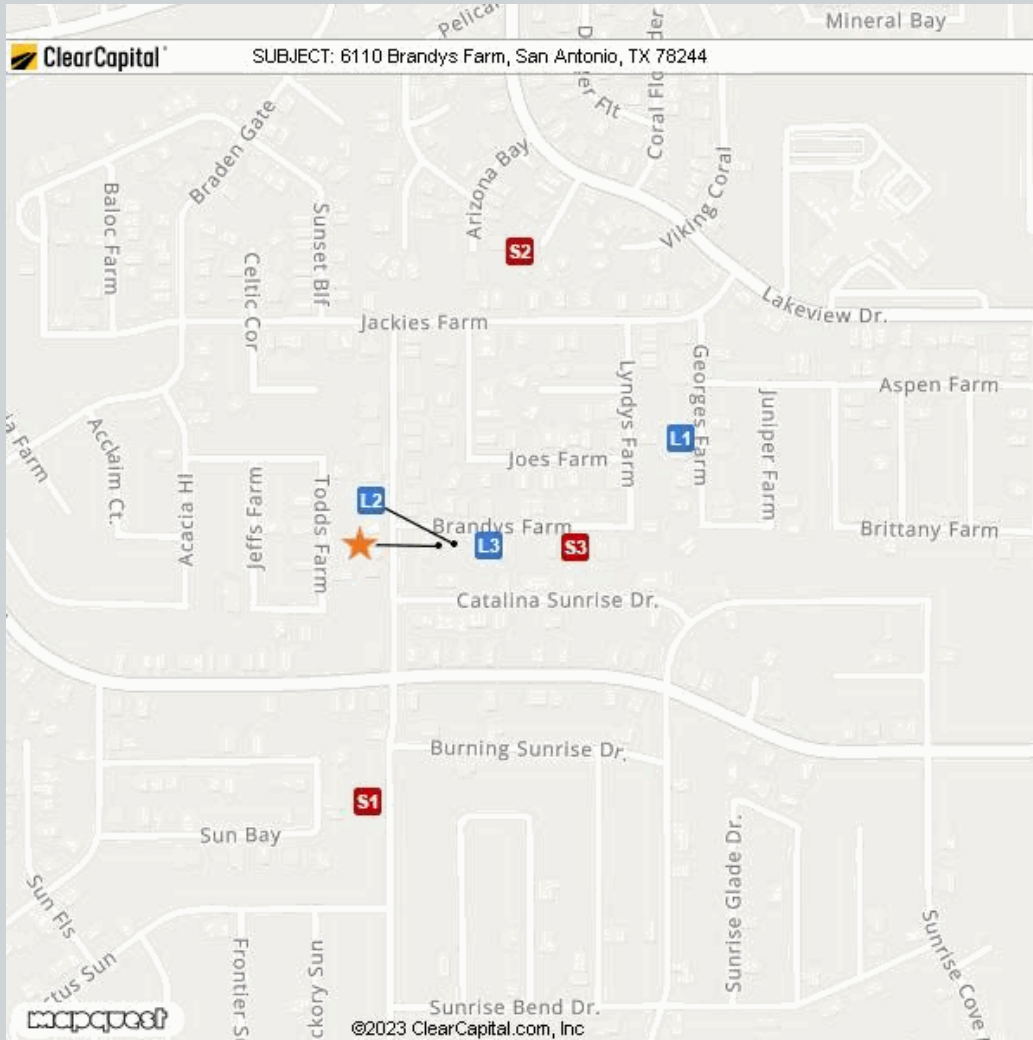
