I made sure to get a SC and LC that bracketed the age, sq ft, foundation, lot size and guest house I went back 03 months, out in distance 0.50 miles, and even with relaxing the GLA search criteria I was unable to find sufficient comps which fit the client's requirements. Within 25 miles and back 12 months I found 11 comps of which I could only use 6 due to subject homes characteristics and marketing factors. The ones used are the best possible currently available comps within 25 miles and the adjustments are sufficient for this area to account for the differences in the subject and comps.</p>		

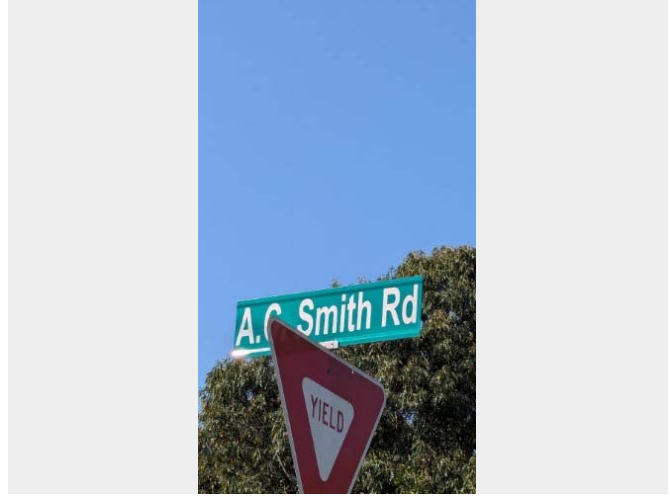
