#### **Comments Regarding Pricing Strategy**

The choice of comparable has been made in terms of proximity to the subject and appears to be the best available at this moment. The utilized comparable are as similar in GLA, style and age as possible. Subject is unique in lot size to its neighborhood. Due to limited comps in the area, all list comps and LC1 were used despite the over 20% lot size difference as it is still considered to be a reliable comparables. Used sales over 6 months old due to the lack of more recent sales from the subject's immediate area. To find similar criteria comparables, it was necessary to exceed condition, age, bed/bath count, basement and lot size. There were limited GLA similar comps within this market area, which made it necessary to expand the GLA range(over 20%) for comps( CS2, LC1, LC3) to find properties to bracket the subject. Proximity parameters were exceeded and search was extended up to 2.9 miles as there were limited active comparables available upto 2 miles. Due to limited comps in the area, listing comps were used despite not BRACKETING the GLA as they are still considered to be reliable comparables. Comparable CS3 received multiple offers which resulted in an increased final sale price relative to list price. Eventhough subject is located near major roadways, educational institutions, worship place, RR track, highway, park and commercial buildings. This will have no impact on subject value. Due to limited comparable from same location, it was necessary to use comparables from across the major roadways, highway and RR track. However, this won't affect the market value. In delivering final valuation, most weight has been placed on CS1 and LC1, as they are most similar to subject condition and overall structure. Subject attributes are from Tax record. I have attached cma to this report.




