Comments Regarding Pricing Strategy

I went back 12 months, out in distance 1 mile, and even with relaxing +/-20 year built, +/-20% GLA search criteria I was unable to find any comparables which fit the subject requirements. Due to limited comparable it was necessary to exceed the proximity up to 4 miles, condition, bed/bath count and lot size. Comparable received multiple offers which resulted in an increased final sale price relative to list price. Subject is located closer to main road, railway track and commercial. This however, will not have effect on value and marketability. In delivering final valuation, most weight has been placed on CS2 and LC3, as they are most similar to subject condition and overall structure. Subject attributes are from Tax record.

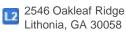

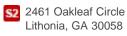

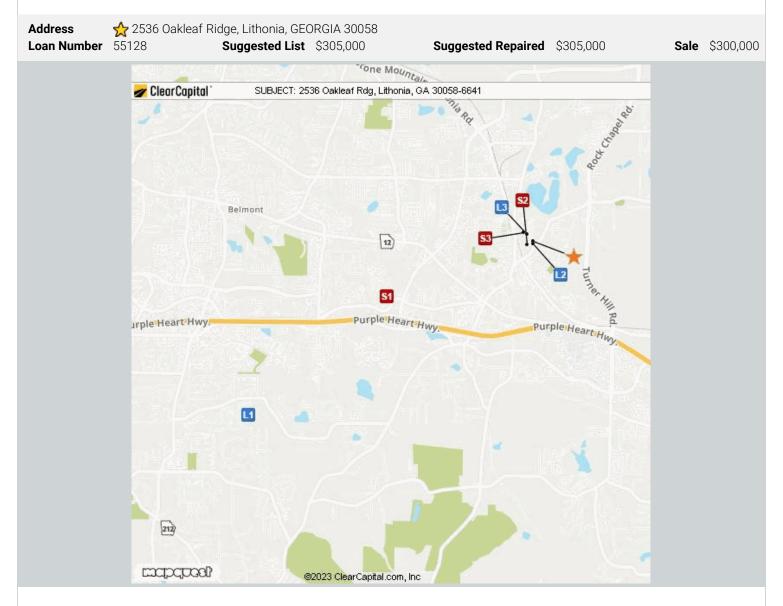
