Due to limited comparable it was necessary to exceed the proximity up to 4 miles, condition, bed/bath count and lot size. Comparable received multiple offers which resulted in an increased final sale price relative to list price. Subject is located closer to main road, railway track and commercial. This however, will not have effect on value and marketability. In delivering final valuation, most weight has been placed on CS2 and LC3, as they are most similar to subject condition and overall structure. 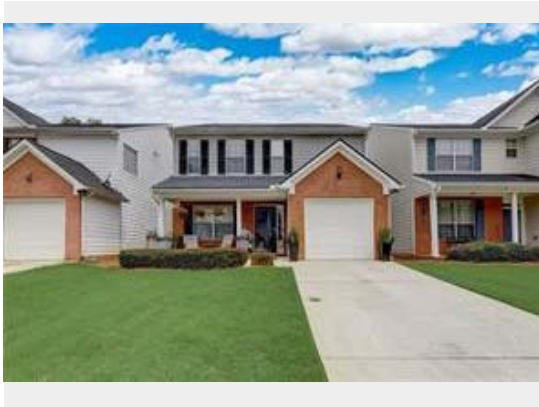

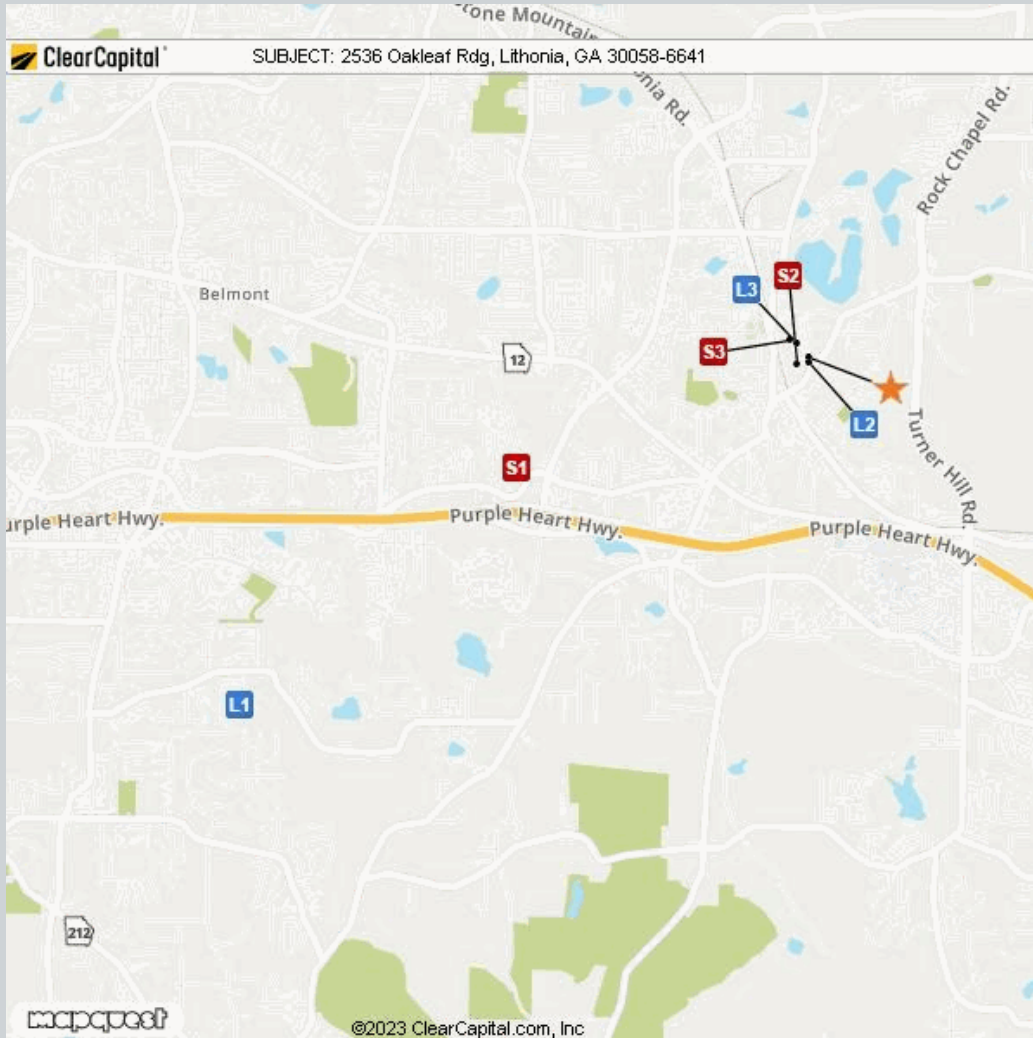
