With the values of smaller sqft homes in this area devaluing as much at 5-20% over the last 6 months. Over the past 5 months the builders have become very flexible in pricing, offering monies to buy down the interest rates, and commissions over 3%+. REOS postings for trusted sales have increased in this area. The subject is in a condition that will not require any repairs to be marketed in it's as-is condition and received full market consideration.</p>
