<p>Sales considered had a sale date within the last 12 months. Used sales over 3 months old due to the lack of more recent sales from the subject's immediate area. Within 1 mile, 20% GLA +/-, Year built 10 +/-, there were limited active comparables available in the subject neighborhood. Therefore it was necessary to exceed the condition, garage count, lot size and proximity up to 1.5 miles. Comparable CS3 received multiple offers which resulted in an increased final sale price relative to list price. Due to the lack of the sold comps, I was unable to use two comps having pending date within 120 days. Price range was over 15% in difference due to the neighborhood area hard to find comparable that is similar to subject in condition and criteria. The value and marketability will not be affected with the subject being located near busy street, major road, water bodies, educational institutes, worship places and commercial buildings. Comparables used in this report are from same location and neighborhood. In delivering final valuation, most weight has been placed on CS1 and LC2, as they are most similar to subject condition and overall structure. Subject attributes are from Tax record.</p>

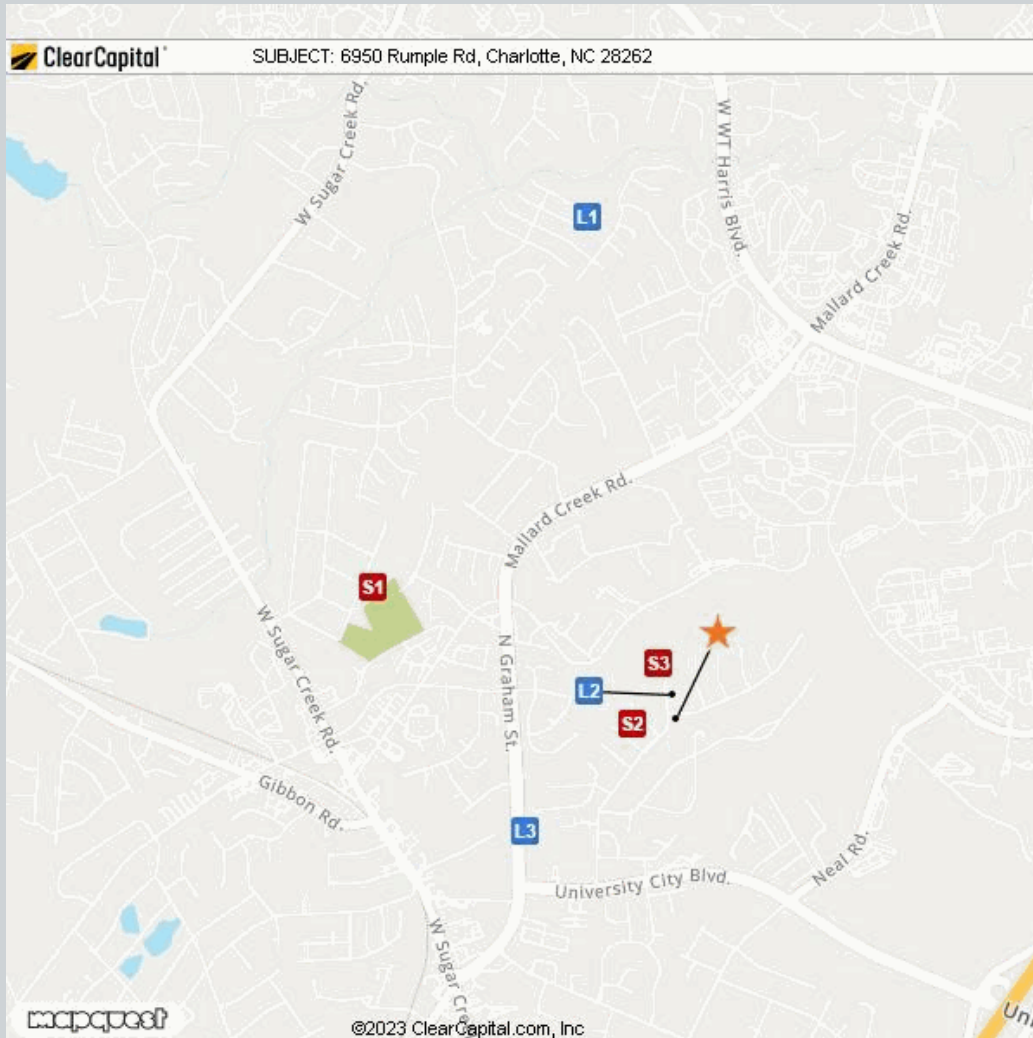
