The older & newer tracts are equally interspersed through out the area, along with some remaining sections of undeveloped land. For these reasons it is often necessary to expand search to find comps. This is considered to be a good commuter location with 2 major commuting routes within 2 miles. Several schools are within a 2 mile radius. Moderate sized newer shopping areas are within 2 miles. Large regional shopping center is about 7 miles away.

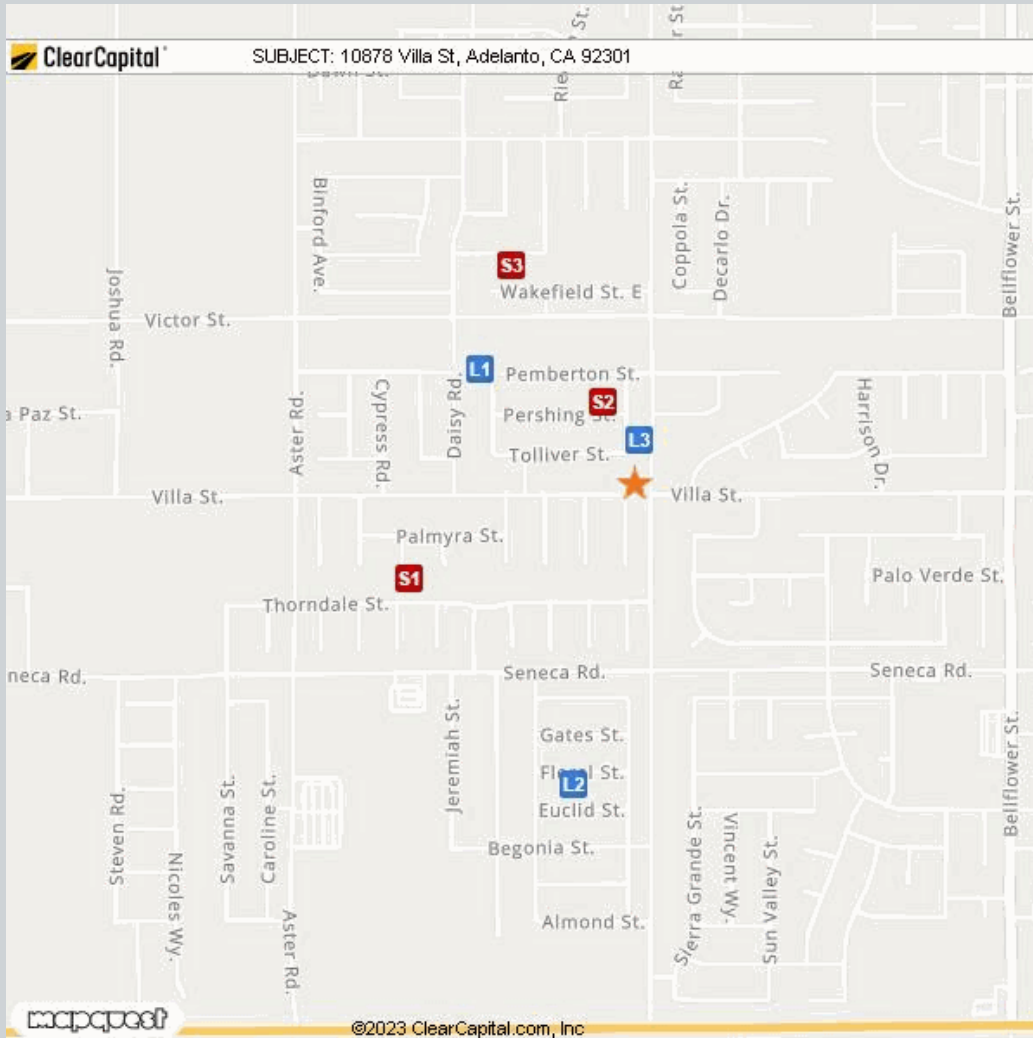
