All comps were the closest possible to the subject in lot size, sq ft., and age, no better sale and active comps were found; therefore I include comps over 1 mile far from the subject property with inferior and superior features. I went back 11 months, out in distance 1miles, GLA 20%-30% variance, age 30 years variance, lot size within 0.10-0.50 acre. The comps used are the best possible currently available comps within 1-mile and the adjustments are sufficient for this area to account for the differences in the subject and comparables. The estimated adjustments for the comparables noted are as follows; GLA \$70 per square feet variance, lot size \$1000 (if reached more than 1.00 acre variance), age \$1000 every year variance, bed \$7000 per bed count, and garage \$4000 per garage space.


