<p>The address was not posted anywhere on the subject, it was verified through tax records, So I uploaded the street sign and neighborhood address photos for the address verification. The subject should be sold in as-is condition. Value best supported by sold comp 1 and list comp 3, being the most comparable to the subject. The subject should be sold in as-is condition. The market conditions is currently Stable. Due to suburban density and the lack of more suitable comparisons, it was necessary to exceed over 1 mile from the subject, over 6 months from inspection date, guidelines for gla, lot size, age and some recommended guidelines when choosing comparable properties. Proximity to the highway and commercial would not affect subject's marketability and both sides of the highway and commercial are similar market areas. There is lack of similar comps available within a mile so it was necessary to extend the search for comps. The prior report subject showing \$383000 but subject is currently listing for \$429000, so we chosen comps for subject market area.</p>

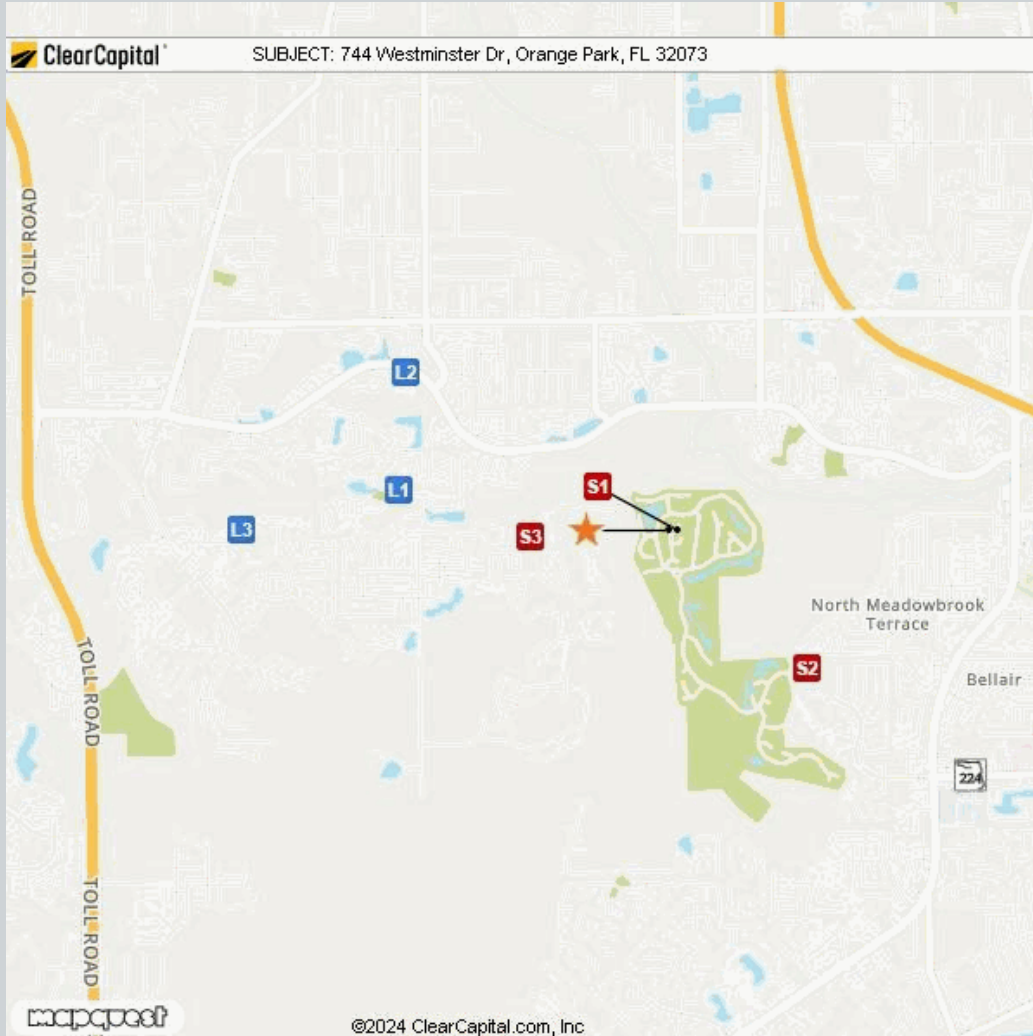
