Every effort made to find/use comps with as close proximity as possible. In this case search was expanded up to 1 mile, although most of the comps are within 1/2 mile. Most of the comps are from same tract as subject. The market is still strong in this area, on properties in this value range. However the market has started to transition &amp; inventory is increasing-note that the active listings have longer DOM than the closed sales. Many listings are seeing price reductions, some substantial. Many sales do involve seller paid concessions, usually for interest rate buy down. Rehabbed properties are still selling at the top of the market.</p>

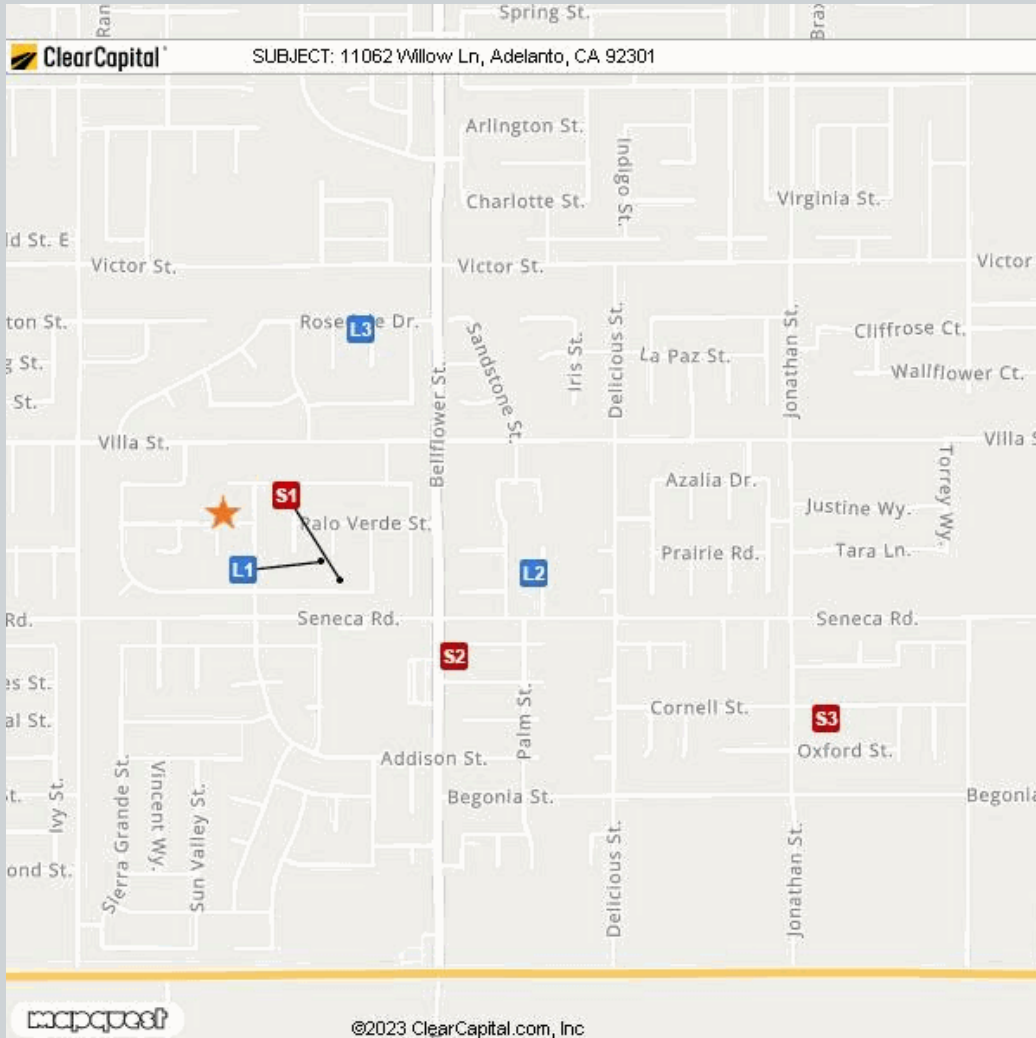
