Bedroom Counts: The subject's bedroom and bathroom counts have been estimated for this report as they are not available in Tax or Public Records. Subject's Pricing: The subject's Sale Price has been bracketed within the range of comp values with the most weight placed on Sale 2 due to its similar attributes. 




