Criteria expansions had to be made due to a lack of available comparables. These expansions include: GLA and proximity. Due to limited listing comps in the area, comp were used despite not bracketing the GLA as they are still considered to be reliable comparable. Comparable S1 received multiple offers which resulted in an increased final sale price relative to list price. Comps selected for this report are all settled properties within the subject's market area. They are considered to be the best available at the time of the inspection and good indicators of market value. The two most similar comps, Sale 2 and List 1, influenced the subject's value the strongest. Property is located in proximity to major roads, highways along with Commercial establishments, schools and parks nearby.</p>

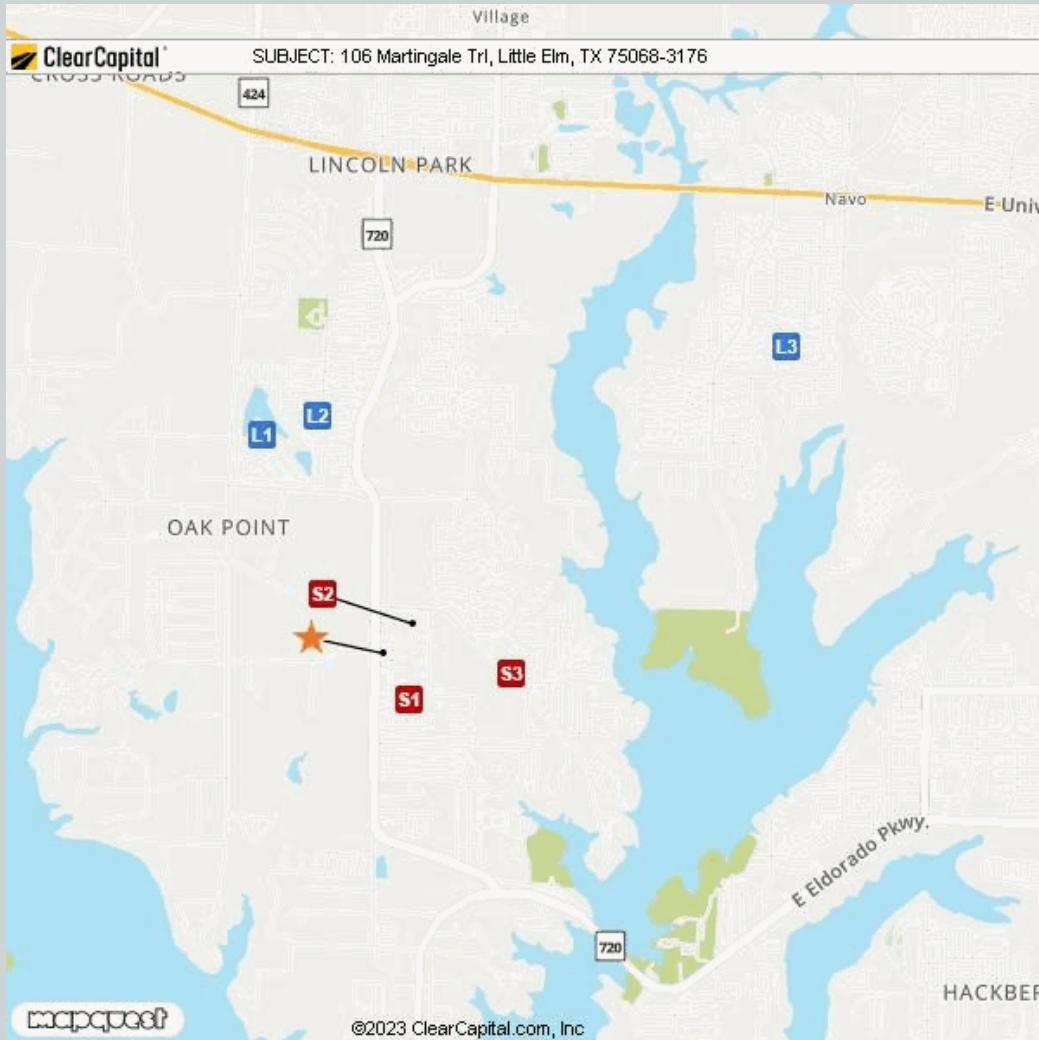
