<p>Subject's Pricing: The subject's Sale Price is bracketed within the range of comp values. Similar comps within the subject's market area support a Sale Price for the subject which is slightly higher than the subject's most recent sold price. The subject property is a single family home, which is in overall average condition on the exterior. The exterior of the subject property does not appear to be in need of repairs. Similar comps were searched for within a distance of 1.75 Miles and back up to 6 months in time. Listing comps were searched for beyond 1 Mile in order to locate comps similar in year built and GLA. The year built tolerance searched for comps was expanded due to limited similar comps within the subject's market area. The GLA Tolerance searched for similar comps was +/- 20% of the subject's Sq. Ft. The subject is in average exterior condition and there is a shortage of similar average condition comps. As such, it was necessary to use two superior condition comps within this report. Inventory is decreasing, and demand is stable within the subject's market area. REO/SS are less than 1% of recent sales and listings in this area. The subject property does not have any major negative site influences.</p>

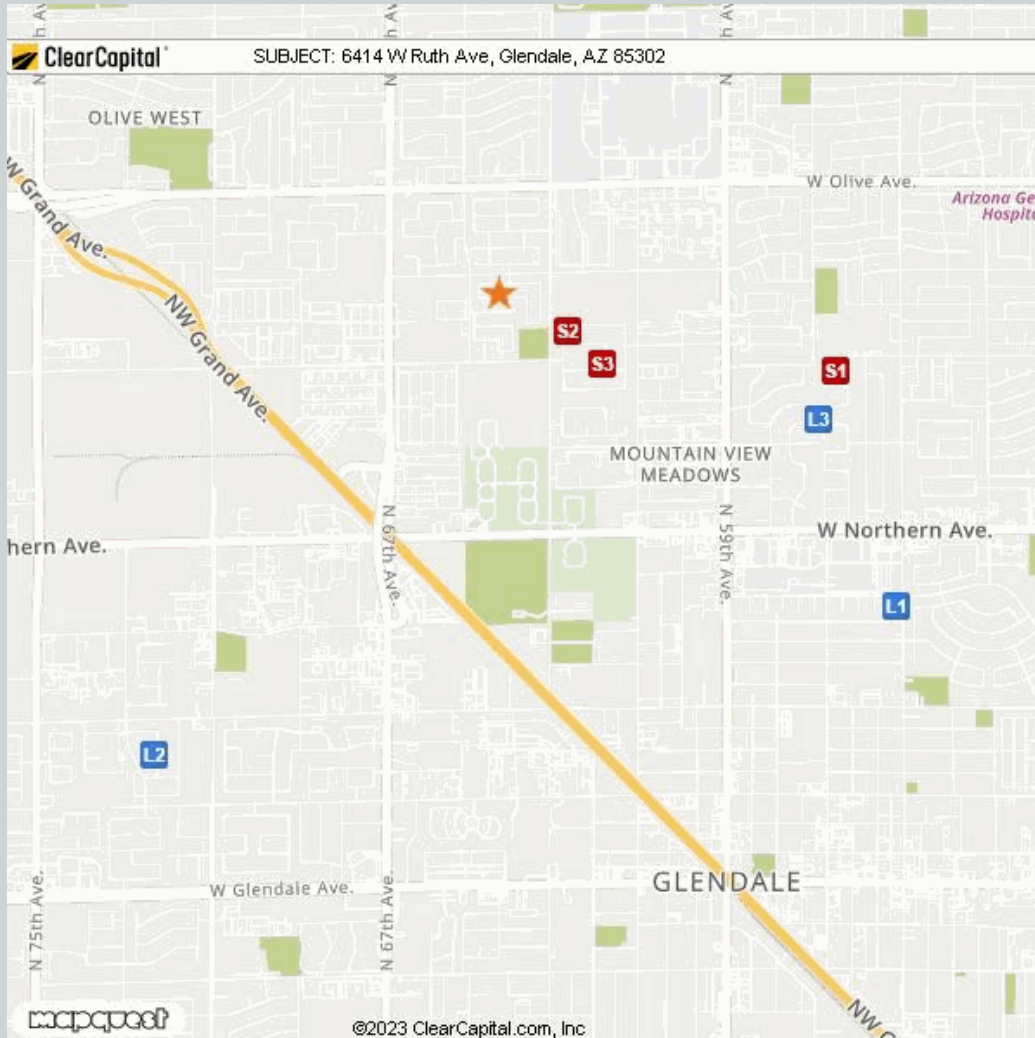
