Therefore, comps were used which are as similar in GLA to the subject as possible, and the sold comps were adjusted for this difference. Subject's Pricing: The subject's Sale Price is bracketed within the range of comp values, with the most weight placed on Sale 2 due to its similar attributes to the subject. Similar comps within the subject's market area support a Sale Price for the subject which is higher than the subject's most recent sales price. The subject property is a Townhome, which is in overall average condition on the exterior. The exterior of the subject property does not appear to be in need of repairs. Similar comps were searched for within a distance of 3 Miles and back up to 12 months in time. Listing comps were searched for beyond 1 Mile in order to locate comps similar in GLA and Property Type. 
