Adjustments: \$27,360 due to sq ft, \$1181 due to the lot, -\$2000 due to age, \$3000 due to room count, -\$2500 due to 3-car garage, -\$20,000 due to view.
- **Sold 2** Shows the best support for my value conclusion. Overall, it has the most comparable characteristics and, most importantly, the most similar location/view, which is one of the biggest factors with the subject. Adjustments: -\$1600 due to sq ft, -\$2700 due to the lot, \$3000 due to age, -\$15,000 due to updates, -\$7500 due to balcony, \$2500 due to no spa.

Comments Regarding Pricing Strategy

The comp below was considered, but because it reflected a value very different than the rest of my comps, it was replaced with comps that better supported the market and my final value conclusion. Listings: MLS #44540934/8415 Sports Haven The search was extended back 12 months, out in the distance 1 mile, and even with relaxing 35% GLA search criteria, I could only find a few comps that fit within 20% GLA requirements and similar style and appeal. Within 1 mile and back 12 months, I found 10 comps, of which I could only use 6 due to condition or site-size factors. The comps used are the best possible currently available comps within 1 mile, and the adjustments are sufficient for this area to account for the differences in the subject and comps. Upon review of all the pertinent information, an opinion of the as-is market value of \$435,000 is adequately supported with emphasis placed on List No. 2 and Sale No. 2. Based upon an exterior inspection from the street, the subject property has no observable adverse condition noted that would cause a safety or health risk/concern at the time of inspection. No resale issues are foreseen.




