Used comparables over 120 days, although they vary in the sale date from inspection date, they are still considered reliable to subject property.</p>

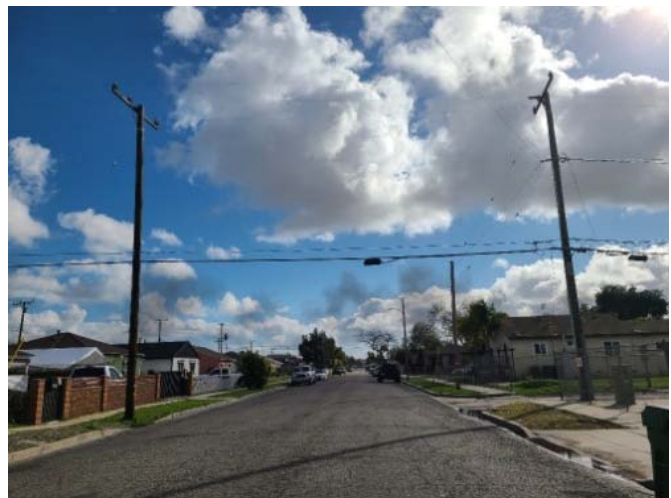

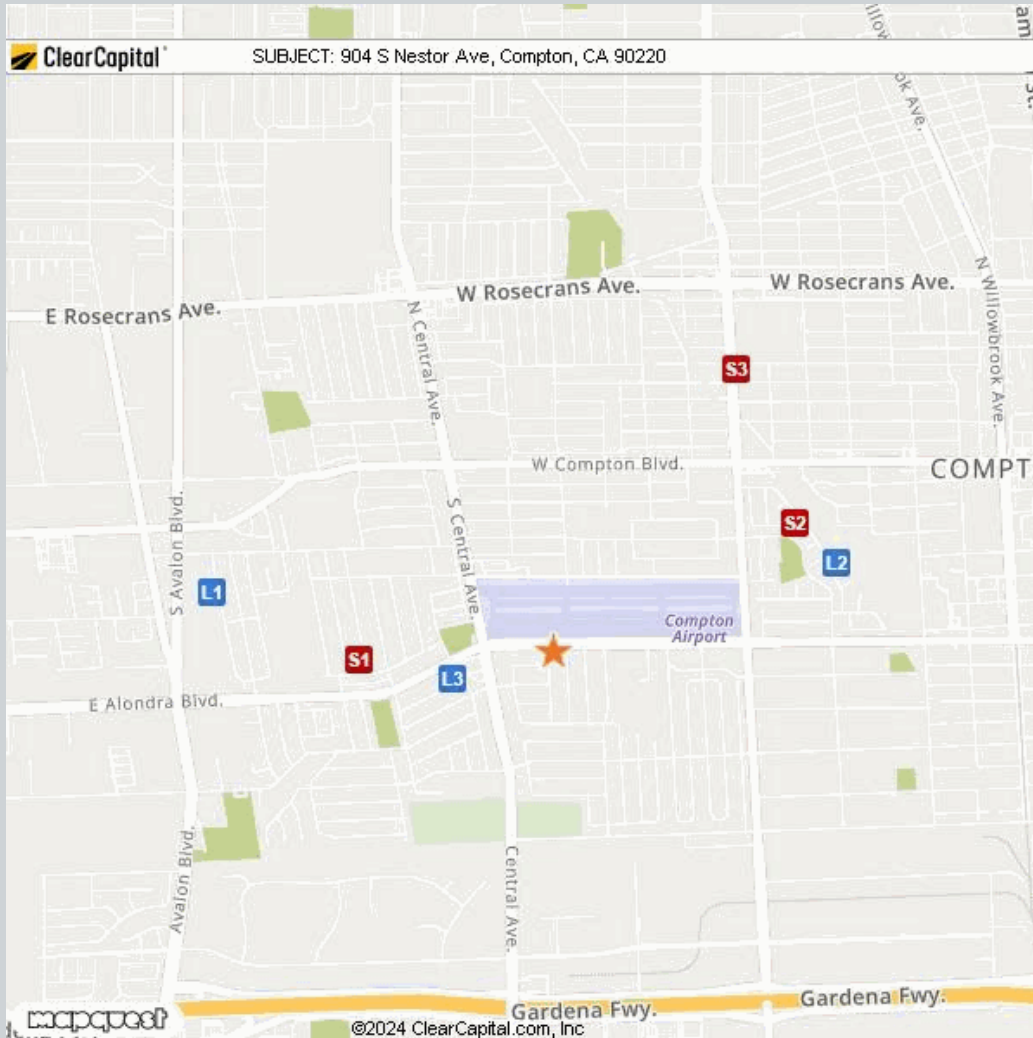
