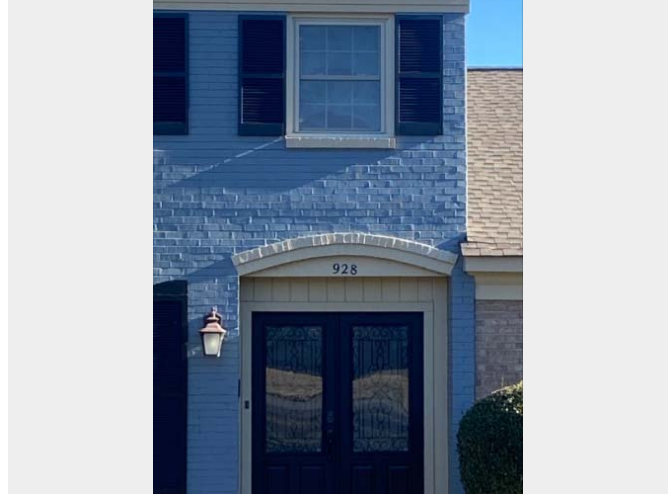
### Clear Capital Quality Assurance Comments Addendum

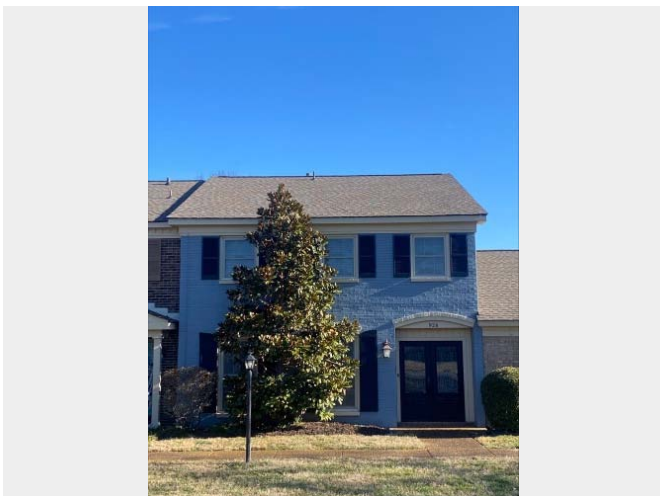

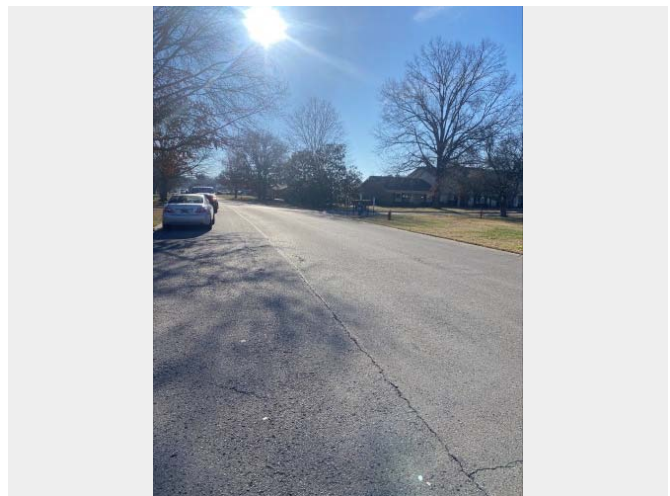

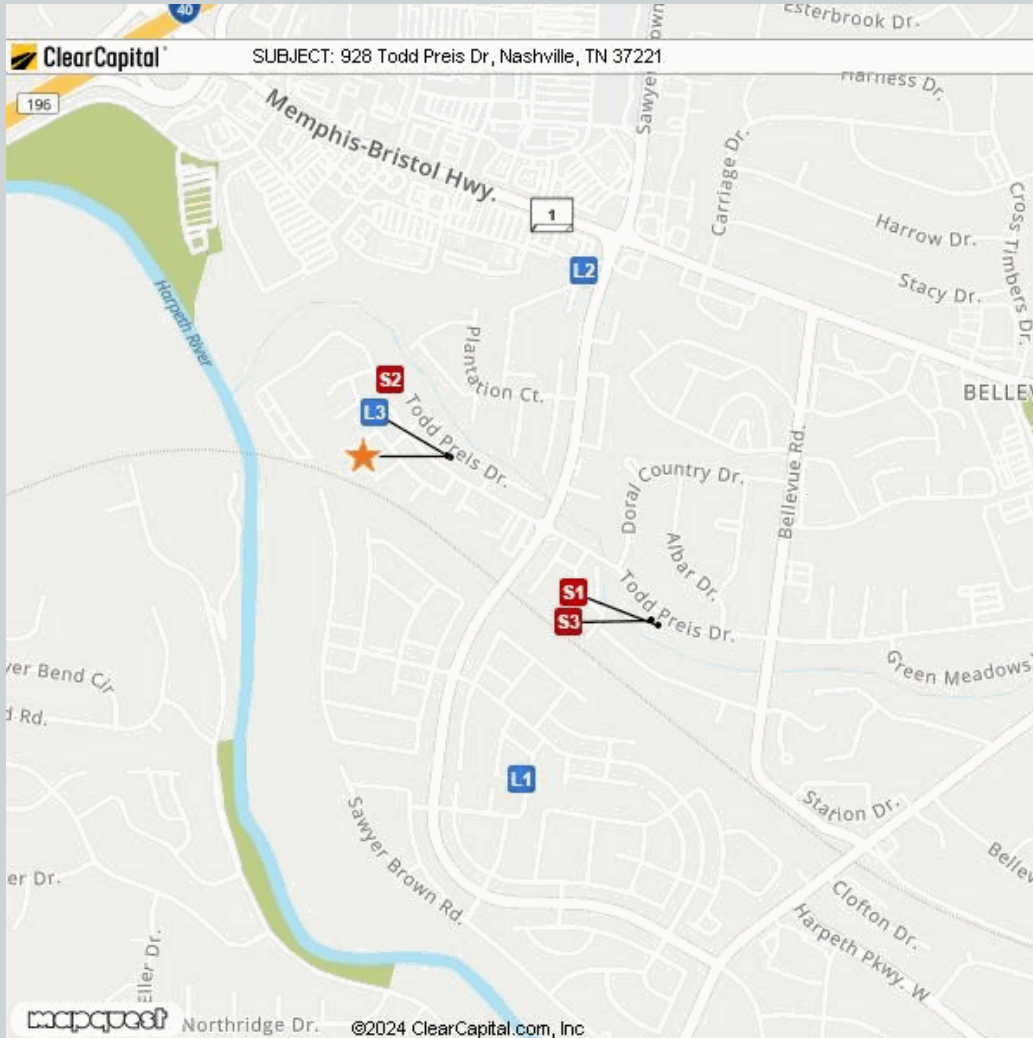
