Available inventory remains limited and interest rates remain relatively low despite recent increases; these factors are driving and sustaining demand. The market is sale driven, and the sold comps are used to establish the subject value; sold comps were considered up to 1 year back due to proximity concerns (the market has not been rapidly changing but gradually appreciating in the last year; however, appreciation is now slowing due to interest rate increases, inflationary pressures and severe lack of inventory and affordability for average end-user buyers). 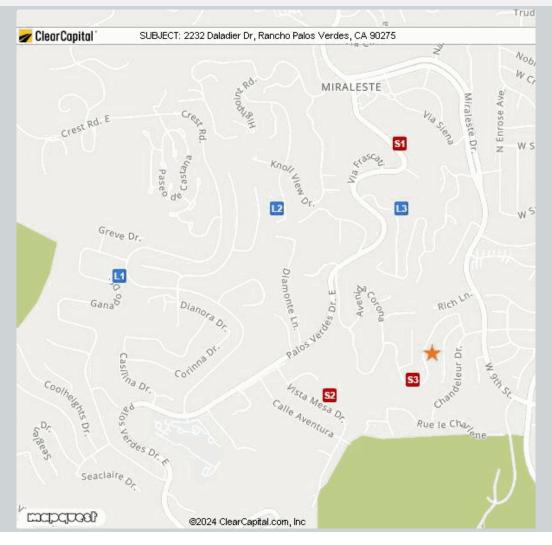
