Fully fenced & x-fenced lot, some trees, shrubs. Front porch. Rear covered patio. New appliances, light fixtures, interior paint. <p>Subject property is one of the smaller homes in the area. Search was expanded in distance to find best comps & to try & bracket subject features, including GLA. Every effort made to find/use comps with as close proximity as possible. In this case search was expanded up to 1.5 miles for active comps. Most of the comps are well within 1 mile of subject. It should be noted that while the market is still very strong for properties in this value range, the active comps support a value at or below the most recent closed sales. Rehabbed properties do still sell at the top of the market. Many sales do involve seller paid concessions, usually for interest rate buy down. This is something that should be expected with any offer currently. Note that 2 of the sold comps used here had subsantial concessions paid.</p>

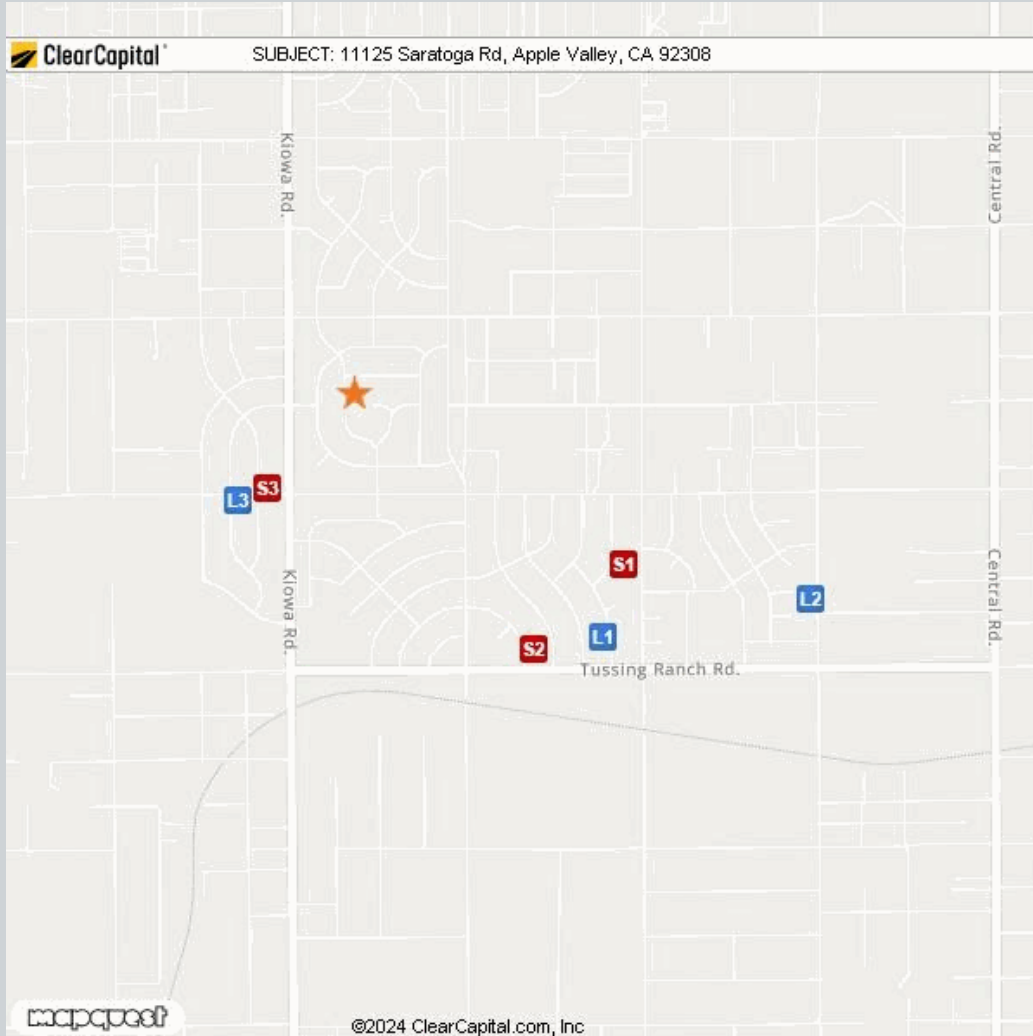
