Due to the limited number of comps in the local market it was necessary to use a comparable that was slightly outside the allowable price threshold.</p>

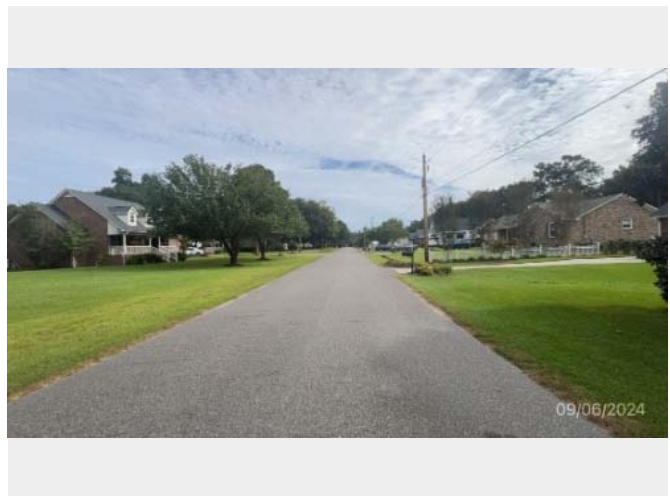

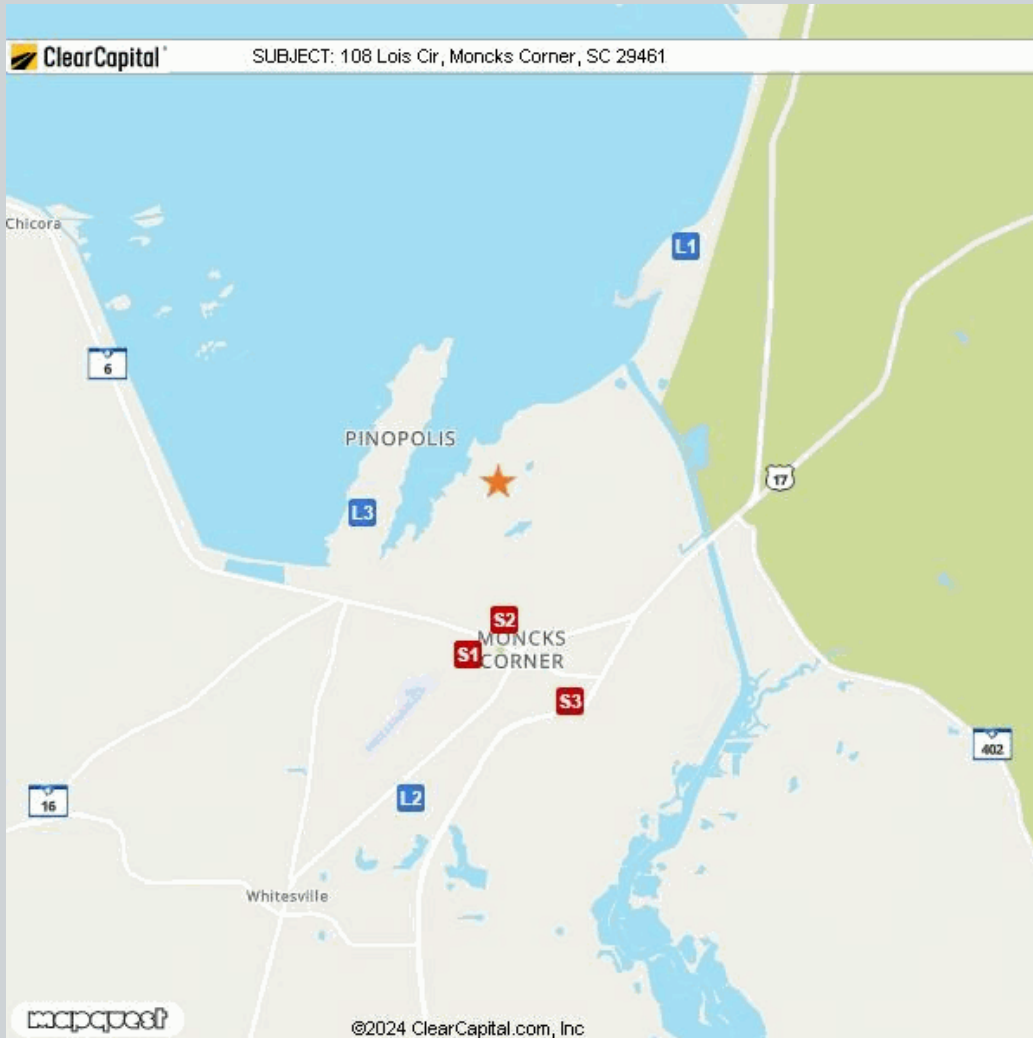
