Comments Regarding Pricing Strategy

Subject details are taken from tax records. The comp pricing provided are for current market conditions and they do provide a basis point for current subject price opinion. To locate comparables in close proximity of subject, it was necessary to exceed closed date, condition, style and bed/bath count. Due to limited comps in the area, both sold and active comps were used despite not bracketing the year built and bed count as they are still considered to be reliable comparable. Comparable S1 and S3 received multiple offers which resulted in an increased final sale price relative to list price. There were no comparables found within 1 mile having similar bed count. To reach a value conclusion, most weight was placed on CS2 and LC1, as they are most similar to subject condition and overall structure. The Subject is located closer to the main road, park, water body, school, busy road and commercial area. This however, will not have an effect on value and marketability.


