Therefore, I was forced to exceed proximity(3 mile), lot size used what was available and the comparable selected were considered to be the best available. The comps however are valuable and bracket the subject well in terms of condition and size. Most weight has been placed on CS3 and LC3 as they are most similar to subject condition and overall structure.</p>

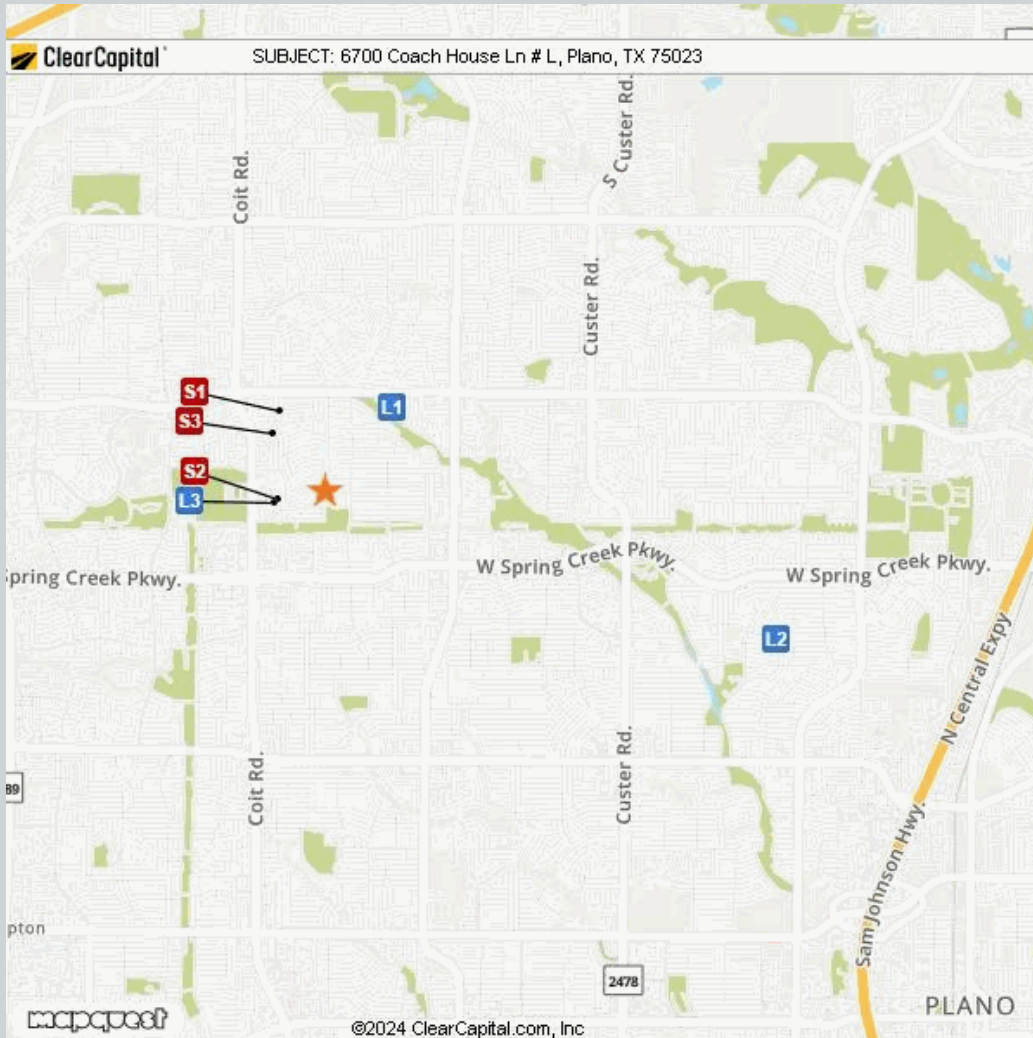
